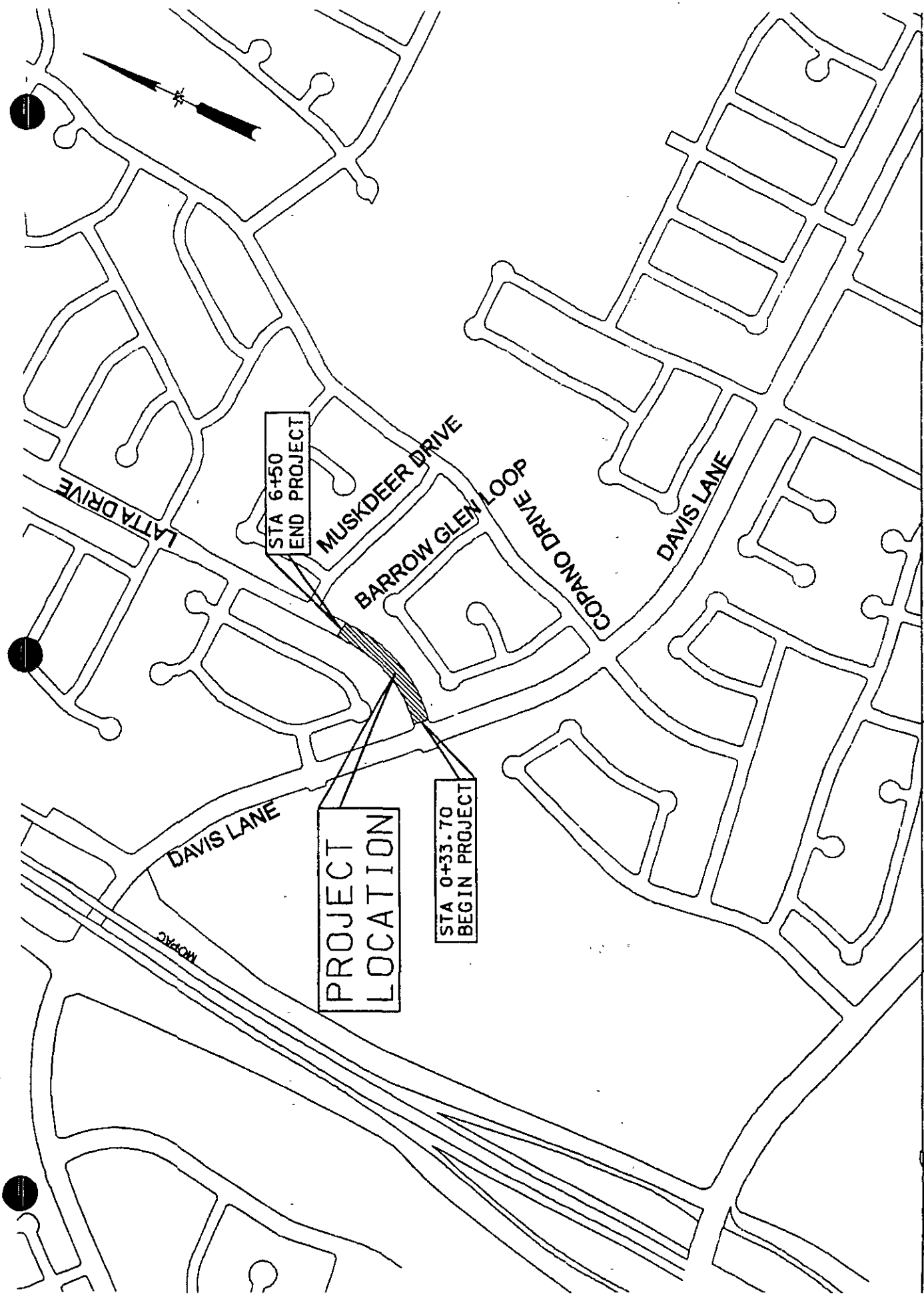

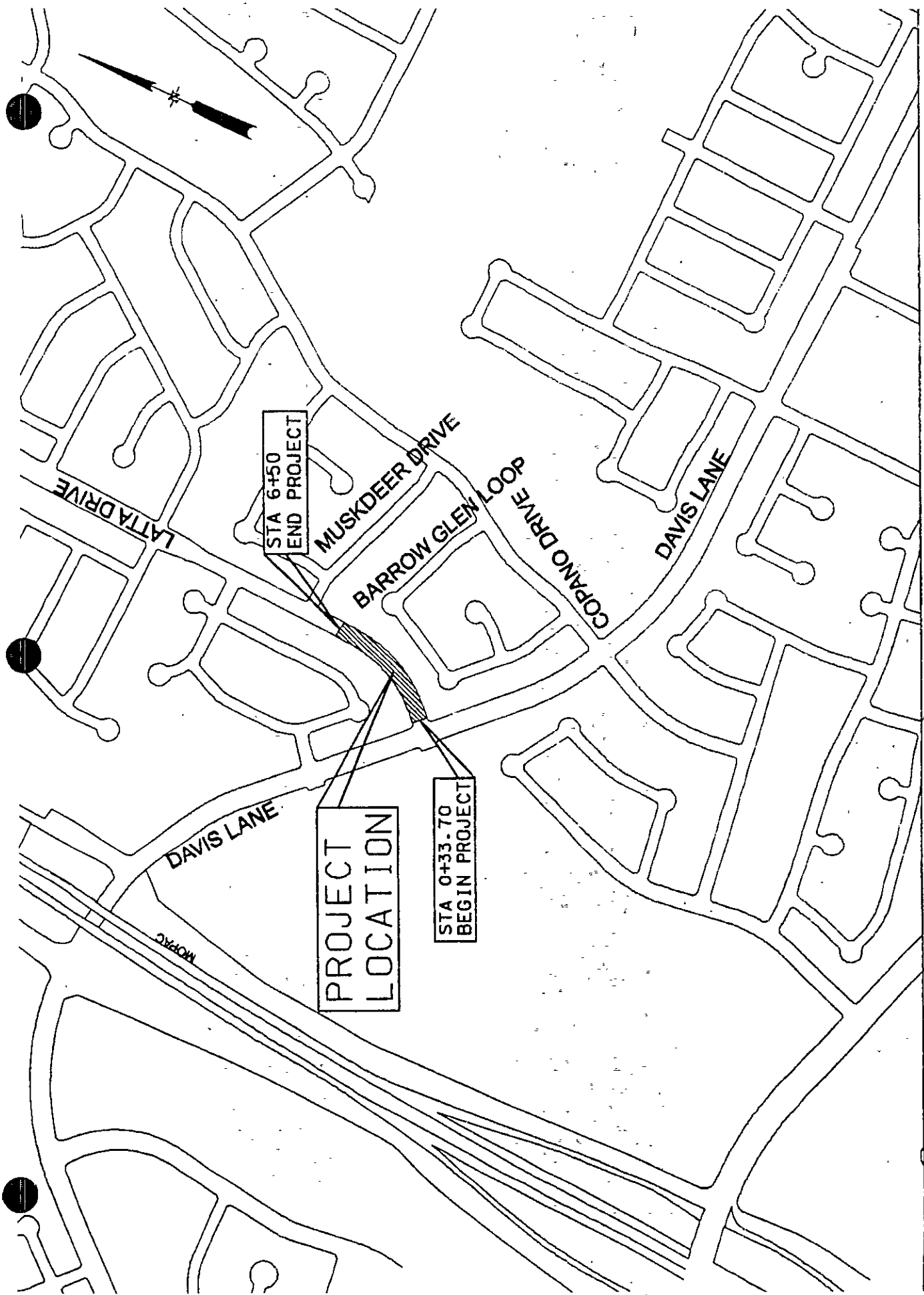
**MBE/WBE:** 6.56% MBE and 12.33% WBE subcontractor participation.

Latta is an arterial roadway with a very short missing segment immediately north of Davis Lane. This project will construct the missing segment and complete the arterial grid network in this area, as well as eliminate some unnecessary cut-through traffic on residential streets that currently occurs due to the lack of arterial connectivity.

The Latta Drive Extension Project is a Capital Improvement Project that involves 650 linear feet of clearing and roadway construction. The proposed road is an extension of Latta Drive from Muskdeer Drive to Davis Lane in Austin, Texas. In addition, 1300 linear feet of curb and gutter and 6300 square feet of sidewalk will be constructed.

Bid documents were distributed to three general contractors. Bids were opened May 25, 2006. Aaron Concrete Contractors, LP submitted the lower of two bids received:

Aaron Concrete Contractors, LP	\$380,963.00
Smith Contracting Co, Inc	\$388,375.00

The contractor's choice of work methodology provides for subcontracting opportunities in three areas which are listed below. Participation sub goals stated in the solicitation were 2.40% African American, Hispanic 10.18%, Asian American .30%, Native American 0.00%; & 10.17% WBE.
