RECOMMENDATION FOR COUNCIL ACTION

ITEM No. 36

Subject: Authorize execution of a construction contract with VIKING CONSTRUCTION INC., Georgetown, TX, for the 2006 Miscellaneous Streets Slurry Project Rebid, which will provide preventive maintenance asphaltic slurry seal on selected cul-de-sacs throughout the City, in an amount not to exceed \$461,142.74.

Amount and Source of Funding: Funding is available in the Fiscal Year 2005-2006 Approved Operating Budget of the Public Works Department.

Fiscal Note: There is no unanticipated fiscal impact. A fiscal note is not required.

The 2006 Miscellaneous Streets Slurry Seal Project Rebid will provide preventive maintenance in the form of application of an emulsified asphalt slurry seal on selected cul-de-sacs within the City of Austin. Crack sealing and minor surface patching is included in the contract as required to prepare street surfaces for the application of the slurry seal.

Bid documents were distributed to two general contractors. Bids were opened June 1, 2006. Viking Construction Inc. submitted the lower of two bids received:

Viking Construction, Inc., Georgetown, TX \$461,142.74 Ballou Construction Co., Inc., Salina, KA \$486,799.40

The contract allows 50 working days for completion of this project.

The contractor's choice of work methodology provides for six areas of subcontracting opportunities: crack sealing and hot mix surface replacement; hauling aggregate, supply of asphalt emulsion, supply of aggregate, supply of cement, and supply of pavement markers.

Participation goals stated in the solicitation were 5.55% MBE; 5.70% WBE. Total participation estimated on base bid amount of \$461,142.74:
