Subject: Approve an ordinance authorizing acceptance of \$31,000 in grant funds from the CAPITAL AREA FOOD BANK; and amending the 2005-2006 Parks and Recreation Department Operating Budget Special Revenue Fund of Ordinance No. 20050912-001 to appropriate \$31,000 for a total grant of \$50,000 for the Kids Café located at the Montopolis Recreation Center and Dove Springs Recreation Center.

The Kids Café is an after school meal program funded through a grant from the Capital Area Food Bank of Texas and American's Second Harvest. The grant provides funding to serve free nutritious hot meals in collaboration with after school and summer enrichment programs to youth ages 5-18 years old that may not have the opportunity to eat regularly at home. During FY 2004- 2005, Dove Springs Recreation Center served a total of 18,447 meals. Currently Dove Springs is averaging 150 meals daily (4 days wk) and Montopolis is averaging 100 meals (3 days wk)

The Parks and Recreation Department has received the Kids Café reimbursement grant for the last 3 years. In 2006 the Capital Area Food Bank of Texas and American's Second Harvest awarded an additional \$31,000 towards the 2005-2006 Fiscal Year which will enable the Department to expand the Montopolis Recreation Center program and provide additional meals at the Dove Springs Recreation Center.

By this action Council will be accepting the additional \$31,000 required to expand this program.

AN ORDINANCE AUTHORIZING THE ACCEPTANCE OF GRANT FUNDS AND AMENDING THE FISCAL YEAR 2005-2006 PARKS AND RECREATION DEPARTMENT OPERATING BUDGET OF ORDINANCE NO. 20050912-001 TO APPROPRIATE GRANT FUNDS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The Council authorizes the acceptance of \$31,000 in grant funds from the Capital Area Food Bank.

PART 2. The Council amends the Fiscal Year 2005–2006 Parks and Recreation Department Operating Budget Special Revenue Fund of Ordinance No. 20050912-001 to appropriate \$31,000 for a total grant amount of \$50,000 for the Kids Cafe located at Montopolis Recreation Center and Dove Springs Recreation Center.
