


Fiscal Note: There is no unanticipated fiscal impact. A fiscal note is not required.



In order to modify or alter the existing speed limit of a street, the Texas Traffic Laws require that a traffic engineering investigation be performed. An investigation of Parker Lane was conducted by the Transportation Division of the Public Works Department in accordance with the procedures specified in the Texas Procedures for Establishing Speed Zones. The Transportation Division recommends adding the following to the City Code Section 12-4-63 (20 MPH School Zone):

Amendment to Code Section 12-4-63 (20 MPH School Zone):

Add: Parker Lane from 200 feet north of Wickshire Lane to 232 feet south of Wickshire Lane (Linder Elementary School).



ORDINANCE NO.

AN ORDINANCE AMENDING SECTION 12-4-63 OF THE CITY CODE TO ADD A PORTION OF PARKER LANE TO THE LIST OF STREETS HAVING A **MAXIMUM SPEED LIMIT OF 20 MILES PER HOUR IN A SCHOOL ZONE** FOR LINDER ELEMENTARY SCHOOL; AND PROVIDE FOR EMERGENCY PASSAGE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Section 12-4-63 (20 Mile Per Hour School Zones) of the City Code is amended to add:

Parker Lane from 200 feet north of Wickshire Lane to-232 feet south of Wickshire Lane (Linder Elementary School).

PART 2. The amendments made in this ordinance shall be incorporated in alphabetical order and the existing subsections renumbered accordingly.

PART 3. Council finds that school will begin before 10 days from the approval of this ordinance, and this constitutes an emergency. Because of this emergency, this ordinance takes effect immediately on its passage for the immediate preservation of the public peace, health and safety.
