Subject: Approve an ordinance authorizing acceptance of \$338,946 in grant funds from the TEXAS DEPARTMENT OF STATE HEALTH SERVICES (DSHS), NUTRITION SERVICES SECTION, Austin, TX; and amending the Fiscal Year 2005-2006 Health and Human Services Department Operating Budget Special Revenue Fund of Ordinance No. 20050912-001, to appropriate \$338,946 for the Women, Infants and Children (WIC) Program for a total grant amount of \$4,504,946 to enhance health care at no cost to low-income pregnant and postpartum women; infants and, children identified to be at nutritional risk in Austin and Travis County.

Amount and Source of Funding: Funding in the amount of \$338,946 is available from the Texas Department of State Health Services, Nutrition Services Section. The grant period is October 1, 2005 through September 30, 2006. No City match is required. (Related to item 17)

WIC FY06 BUDGET AMENDMENT

Background

The Supplemental Nutrition Program for Women, Infants, and Children (WIC) is a preventative program that targets women and children below 185% of federal poverty level. The WIC Program provides nutrition education, breastfeeding support, and vouchers for nutritious foods to pregnant women, infants, and children up to age five.

The Austin/Travis County Health and Human Services Department (HHSD) WIC Program, through funding from the Texas Department of State Health Services, proposed special funding to finish out new lease space for our Parkfield WIC Clinic and Mom's Place Lactation Center. Participation at this clinic has grown 11% since October 2004 and continues to steadily increase each month. The additional space is a necessity to meet expansion needs in our agency.

The purpose of the Services for Women and Children Activity is to provide nutrition and preventative health services to targeted women and children to ensure healthy outcomes.

Percentage of women enrolled in WIC during pregnancy who subsequently breastfeed their children – 82%
