Purchasing Office RECOMMENDATION FOR COUNCIL ACTION

ITEM No. 41

**Subject:** Authorize award and execution of a 24-month requirements supply contract with TURNER COMPANY, Raleigh, NC, for manhole and water valve extension rings for the Austin Water Utility in an estimated amount not to exceed \$168,000, with one 12-month extension option in an estimated amount not to exceed \$84,000, for a total estimated contract amount not to exceed \$252,000.

**Amount and Source of Funding:** Funding in the amount of \$7,000 is available in the Fiscal Year 2005-2006 Approved Operating Budget of the Austin Water Utility. Funding for the remaining 23 months of the original contract period and extension option is contingent upon available funding in future budgets.

Fiscal Note: There is no unanticipated fiscal impact. A fiscal note is not required.
