ORDINANCE NO. 20060831-020

AN ORDINANCE TO AMEND SECTION 12-4-24 OF THE CITY CODE TO ESTABLISH A MAXIMUM SPEED LIMIT OF 25 MILES PER HOUR WITHIN THE AREA BOUNDED BY U.S. HIGHWAY 183, ANDERSON LANE AND BURNET ROAD.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. Section 12-4-24 (Maximum Speed of 25 Miles Per Hour) of the City Code is amended to add the following streets:

Beckett Street from Burrell Drive to Lazy Lane.

Belford Drive from Camden Drive to Bon Air Drive.

Bon Air Drive from Wooten Drive to Belford Drive.

Bowling Green Drive from Lanier Drive to Polaris Avenue.

Brockman Street from Anderson Lane to Pompton Drive.

Camden Drive from Belford Drive to Pompton Drive.

Colfax Avenue from Burnet Road to end of Colfax Avenue.

Contour Drive from Fairfield Drive to Ohlen Road.

Dale Drive from Tisdale Drive to Gault Street.

Emberwood Drive from Teakwood Drive to Richwood Drive.

Exmoor Drive from Pompton Drive to Lanier Drive.

Fairfield Drive from Contour to U.S. Highway 183 (Research Boulevard).

Falmouth Drive from Pompton Drive to Teakwood Drive.

Gault Street from Dale Drive to Wooten Drive.

Hathaway Drive from Polaris Avenue to Shamrock Avenue.

Hathaway Drive from Doris Drive to Ohlen Road.

Joy Lane from Putnam Drive to Woodstone Drive.

Kamar Drive from Kromer Street to Lazy Lane.

Kenbridge Drive from Exmoor Drive to Shadowood Drive.

Kromer Street from Beckett Street to Fairfield Drive.

Lanier Drive from Bowling Green Drive to Shadowood Drive.

Lazy Lane from U.S. Highway 183 (Research Boulevard) to Wooten Drive.

Mahone Avenue from Burnet Road to Camden Drive.

North Plains Avenue from Brockman Street to Sales Street.

Payton Gin Road from U.S. Highway 183 (Research Boulevard) to Putnam Drive.

Polar Drive from Beckett Street to Villanova Drive.

Pompton Drive from Brockman Street to end of Pompton Drive.

Putnam Drive from Hearthstone Drive to U.S. Highway 183 (Research Boulevard).

Reeda Lane from Ohlen Road to Doris Drive.

Renton Drive from Richwood Drive to Ohlen Road.

Richwood Drive from Emberwood Drive to end of Richwood Drive.

Ripplewood Drive from Emberwood Drive to Wooten Drive.

Sales Street from North Plains Avenue to Mahone Avenue.

Spearman Drive from Ohlen Road to Teton Drive.

Teton Drive from Spearman Drive to Woodstone Drive.

Tisdale Drive from Anderson Lane to Wooten Drive.

Villanova Drive from Burrell Drive to Kromer Street.

Weyburn Drive from Ohlen Road to Doris Drive.

Weyford Drive from Burrell Drive to Kromer Street.

Woodstone Drive from Joy Lane to end of Woodstone Drive.

Wooten Drive from Falmouth Drive to Bon Air Drive.

Wooten Drive from Lazy Lane (east intersection) to Gault Street.

PART 2. The City Council finds that the prima facie speed limit previously applicable to the streets, or portions of streets, identified in Part 1 of this ordinance is unreasonable or unsafe, and the reduction in speed limit on these streets will reduce the potential for vehicle-pedestrian accidents.

PART 3. The amendments made in this ordinance shall be incorporated in alphabetical order and the existing subsections renumbered accordingly.

PART 4. This ordinance takes effect on September 11, 2006.
