
Amount and Source of Funding: Funding is available in the Fiscal Year 2005-2006 Capital Budget of the Austin Water Utility.

This project is a result of an agreement between the City of Austin and the Anderson Mill Municipal Utility District (M.U.D). This construction contract will provide for decommissioning the lift station that is currently part of the Anderson Mill M.U.D. In addition, about 800 linear feet of 15-inch diameter wastewater main will be installed to provide service for a mostly residential area located in the north section of Austin near U.S. 183 and Lake Creek Parkway. The wastewater main will be installed at the intersection of Millstone and Meadowheath Drive.

The contract allows 130 calendar days for completion of the project. Work is expected to begin in November 2006.
