#### Public Hearings and Possible Actions RECOMMENDATION FOR COUNCIL ACTION

#### ITEM No. 53

**Subject:** Conduct a public hearing and consider a request for a waiver from the minimum distance requirement of City Code, Section 4-9-4(A) which requires 300 feet between a business that proposes to sell alcoholic beverages at 1000 West Lynn Street ("Galaxy Cafe") and a public school, Mathews Elementary School, at 1111 West 6th Street, Austin, TX.

Fiscal Note: There is no unanticipated fiscal impact. A fiscal note is not required.




The owner of Galaxy Café, Kelly Chappell, requests a waiver from the minimum distance requirement of 300 feet in Section 4-9-4(A) of the Austin City Code because she intends to sell alcoholic beverages at her restaurant which is located 278' from a public school, Mathews Elementary, at 1111 West 6th Street.

Section 4-9-5(A) allows the City Council to walve the 300 foot distance requirement if they determine that the enforcement of the distance requirement in a particular instance:

(1) is not in the best interest of the public;
(2) constitutes waste or the inefficient use of land or other resources;
(3) creates an undue hardship on the applicant;
(4) does not serve its intended purpose;
(5) is not effective or necessary; or
(6) for any other reason the council, after consideration of the health, safety, and welfare of the public and the equities of the situation, determines is in the best interest of the community.

Written objections to the granting of the waiver have been received from Curtis E. Shaw, Director of Construction Management, Matthews Elementary School and Dan Robertson, Associate Director, Austin Independent School District.

#### ALCOHOLIC BEVERAGE WAIVER REQUEST

## NAME AND LOCATION OF RESTAURANT: Galaxy Café, 1000 West Lynn Street

### NAME AND LOCATION OF SCHOOL WITHIN 300 FEET OF PROPOSED SALE OF ALCOHOLIC BEVERAGES: Matthews Elementary School, 1111 West 6<sup>th</sup> Street

ZONING: CS-MU-CO-NP NEIGHBORHOOD PLAN: Old West Austin

<u>APPLICANT</u>: Kelly Chappell

<u>REQUEST</u>: The owner of Galaxy Café, Kelly Chappell, requests a waiver from the minimum distance requirement of 300 feet in Section 4-9-4(A) of the Austin City Code because she intends to sell alcoholic beverages at her restaurant which is located 278' from a public school, Mathews Elementary, at 1111 West 6<sup>th</sup> Street.

Section 4-9-5(A) allows the City Council to waive the 300 foot distance requirement if they determine that the enforcement of the distance requirement in a particular instance:

- (1) is not in the best interest of the public;
- (2) constitutes waste or the inefficient use of land or other resources;
- (3) creates an undue hardship on the applicant;
- (4) does not serve its intended purpose;
- (5) is not effective or necessary; or

Staff recommends denial of the waiver request.

## **RESOLUTION NO.**

WHEREAS, Kelly Chappell, owner of Galaxy Café, has filed an application for a waiver of Section 4-9-4(A) of the City Code which prohibits the sale of alcoholic beverages within 300 feet of a church, public school, or public hospital; and

WHEREAS, Galaxy Café, located at 1000 West Lynn Street, Austin, Texas, is within 300 feet of Mathews Elementary School, located at 11,11 West 6<sup>th</sup> Street; and

WHEREAS, notice of the application and hearing for the waiver was provided in accordance with Section 4-9-5 of the City Code; and

WHEREAS, a public hearing concerning this proposed waiver was held by the City Council on-September-28, 2006, in accordance with the provisions of Section 25-1-132 of the City Code; and

WHEREAS, written objections to the granting of the waiver have been received from Curtis E. Shaw, Director of Construction Management, Mathews Elementary School and Dan Robertson, Associate Director, Austin Independent School District; and

**WHEREAS,** the old West Austin Neighborhood Association has submitted a letter stating no objection to the granting of the waiver; and

WHEREAS, the City Council, after consideration of the health, safety, and welfare of the public and the equities of the situation, has determined that the waiver request is in the best interest of the community; NOW, THEREFORE,

## BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

Kelly Chappell, owner of Galaxy Café, is granted a waiver from Section 4-9-4 of the City Code and is allowed to sell alcoholic beverages at 1000 West Lynn Street, Austin, Texas; and the waiver shall expire on the sale or transfer of the business to any other individual or entity, whether by lease or any other arrangement, on cessation of the business, or on revocation of the alcoholic beverage permits granted to Galaxy Café for this site.
