

LEGAL DESCRIPTION

BEING A PORTION OF THAT CERTAIN STREET IN THE CITY OF AUSTIN, TRAVIS COUNTY, TEXAS KNOWN AS WABASH AVENUE (R O W VARIES), WHICH PORTIONS OF SAID WABASH AVENUE WERE DEDICATED BY THE FOLLOWING DOCUMENTS

- 1) A PORTION OF SAID STREET AS SHOWN ON AND DEDICATED BY THE ELIZABETH M PATTERSON ADDITION, A SUBDIVISION IN THE CITY OF AUSTIN OF RECORD IN BOOK 1, PAGE 95 OF THE PLAT RECORDS OF TRAVIS COUNTY, TEXAS
- 2) A PORTION OF SAID STREET AS SHOWN ON AND DEDICATED BY THE MARTHA E WHITTEN ADDITION, A SUBDIVISION IN THE CITY OF AUSTIN OF RECORD IN BOOK 2, PAGE 198 OF THE PLAT RECORDS OF TRAVIS COUNTY, TEXAS
- 3) PORTIONS OF SAID STREET DEDICATED TO THE CITY OF AUSTIN BY GEORGE WARREN IN ORDINANCE NO 840301-2 APPROVED MARCH 1, 1984, AND RECORDED IN VOLUME 8697, PAGE 136 OF THE DEED RECORDS OF TRAVIS COUNTY, TEXAS
- 4) PORTIONS OF SAID STREET CONVEYED TO THE CITY OF AUSTIN BY DEED RECORDED IN VOLUME 7736, PAGE 251 OF THE DEED RECORDS OF TRAVIS COUNTY, TEXAS.

SAID PORTION OF WABASH AVENUE IS TO BE RENAMED MEDICAL PARKWAY AND IS BOUNDED. ON THE NORTH BY THE PRESENT SOUTH RIGHT-OF-WAY LINE OF WEST 34TH STREET, ON THE EAST BY THE PRESENT EAST RIGHT-OF-WAY LINE OF WABASH AVENUE, ON THE SOUTH BY THE PRESENT NORTH RIGHT-OF-WAY LINE OF WEST 32ND STREET, AND ON THE WEST IN PART BY THE PRESENT WEST RIGHT-OF-WAY LINE OF WABASH AVENUE LYING BETWEEN THE PRESENT SOUTH RIGHT-OF-WAY LINE OF WEST 34TH STREET AND THE PRESENT SOUTH RIGHT-OF-WAY LINE OF WEST 33RD STREET AND THENCE IN A WESTERLTY DIRECTION FOLLOWING THE PRESENT SOUTH RIGHT-OF-WAY LINE OF WEST 33RD STREET TO ITS INTERSECTION WITH THE EXISTING BACK OF CURB ON THE WEST SIDE OF WABASH AVENUE AND THENCE IN A SOUTHERLY DIRECTION FOLLOWING SAID BACK OF CURB ON THE WEST SIDE OF WABASH AVENUE TO ITS INTERSECTION WITH THE PRESENT NORTH RIGHT-OF-WAY LINE OF WEST 32ND STREET AS SHOWN ON THE ATTACHED SKETCH
