Austin Energy RECOMMENDATION FOR COUNCIL ACTION

Subject Approve negotiation and execution of Amendment No 1 to the existing cost reimbursement agreement with SPGIL DOMAIN, L P, previously known as The DOMAIN SHOPPING CENTER L P (Simon Properties), to increase the cost reimbursement in an amount not to exceed \$700,000 for underground utility piping and related equipment at the DOMAIN site, for a revised agreement total of \$4,900,000

Prior Council Action 7-28-2005 Initial Cost Reimbursement Agreement for \$4,200,000 approved

Austin Energy provides, through a separate contract, chilled water cooling services for the new commercial, retail and residential project being constructed next to the DOMAIN site by SPGIL DOMAIN, L P (i.e., Simon Properties) Simon will be supplying the underground utility piping and related equipment necessary for Austin Energy to provide district cooling services to the new development from Austin Energy's existing utility plant at the DOMAIN

Simon is installing the necessary underground piping and related equipment (pumps, valves, heat exchangers) in conjunction with its construction of the new development. This contracting arrangement enables lower installed costs and avoids construction delays, and avoids the need to excavate new areas in the future for extensions of the chilled water distribution system.

Austin Energy has reviewed and approved the design and construction of this chilled water piping project, and has agreed that \$700,000 in additional costs incurred by Simon for piping and appurtenances are qualified and acceptable for reimbursements under the existing agreement, thereby increasing the not to exceed amount to \$4.9 Million

Of note is that Simon assures repayment of this expenditure to Austin Energy in the form of fixed monthly payments calculated such that the entire amount of funding that Austin Energy reimburses Simon for piping, is paid back to Austin Energy over 20 years at a cost of 6% interest. Simon reserves the right to pre-pay the outstanding balance to Austin Energy at any time

Such reimbursement may include appropriate costs incurred by Simon prior to the execution of the Agreement Upon completion and acceptance of the project, Austin Energy will own and maintain the piping and related equipment
