Boards and Commission Action Recommended by the Electric Utility Commission

Prior Council Action 11/17/05 - Approved change order increasing the spending authorization by \$2,100,000 to total of \$5,100,000 (Item 4), 8/26/04 - Approved original \$3,000,000 Building Purchase Agreement (Item 2), 7-29-04 - Approved \$15,500,000 Budget Amendment for new Seton Regional Children's Medical Hospital BCHP (Item 6), 7-29-04 - Approved \$11,000,000 design and equipment contract for BCHP with Burns & McDonnell (Item 52)

Seton has designed and is constructing the structure that houses the Building Cooling, Heating and Power (BCHP) system in conjunction with their construction of the Dell Children's Medical Center of Central Texas. This BCHP system is Austin Energy's new Mueller Energy Center (MEC), which already serves the Dell Children's Hospital and will serve several adjacent clients. Through the Council-approved Building Purchase Agreement, Austin Energy will acquire ownership of the structure following its completion by reimbursement to Seton for the construction costs.

This change order is needed for Austin Energy to meet the accelerated load growth in the area adjacent to the hospital Austin Energy needs to expand the MEC plant capacity earlier than originally scheduled, and is therefore having Seton build-out a planned-for second switchgear room to house a 480-volt electrical switchgear system

The Mueller Energy Center was dedicated on October 17, 2006 The original Building Purchase Agreement was for \$3M, but a relocation of the building increased the expected cost of the structure by \$2 1M due to an extension of two 30 inch chilled water lines and utilities, increased concrete slab dimensions and design requirements, compliance with a wall design surrounding the equipment that blends the structure architecturally with the hospital and surrounding structures, and incorporation of an artfully presented educational display

In other related items, Council approved 1) On June 14, 2004 a reimbursement agreement with Catellus Commercial Development Corporation to install chilled water pipes in the roadway adjacent to the BCHP energy plant, and 2) On July 29, 2004 an agreement with Burns and McDonnell Engineering Co to purchase the BCHP system for a cost not to exceed \$11,000,000
