Campus on October 6, 2005

On October 6, 2005, the Austin City Council approved a budget of \$22,125,000 for the purchase and renovation of commercial property at 8301 Cameron Road. On January 6, 2006, the City of Austin closed on the purchase of this property and renovations were started to make the site suitable for occupancy by various City departments. Among the departments identified for relocation to Cameron Road is the Evidence Control Division of the Austin Police Department.

This contract will provide the Austin Police Department with various shelving units that will include custom bike racks and large evidence storage shelving. Crime scene evidence from multiple locations will be relocated to this facility. This shelving is necessary to allow efficient and proper storage of evidence into the assigned space. Additionally, this shelving will enable the Austin Police Department to meet accreditation standards by improving organization and tracking capabilities.

Currently, the Evidence Control Division is housed in a leased facility. Relocation of Evidence Control to the Cameron Road Campus will avoid future lease costs for additional warehouse space and provide a climate-controlled and more secure location for management and control of their inventory.
