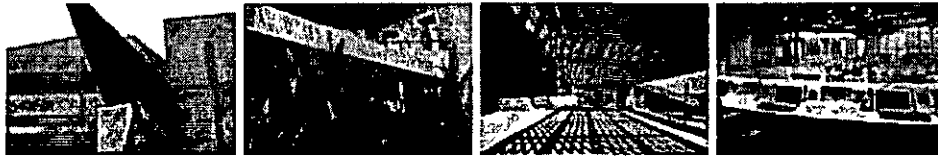

### Purchasing Office RECOMMENDATION FOR COUNCIL ACTION

ITEM No 28

**Subject** Authorize award and execution of a 24-month requirements service contract with ACE FIRE Equipment Co , Inc Austin, Texas for inspection and repair services for the fire alarm and suppression systems at Austin-Bergstrom International Airport, in an estimated amount not to exceed \$477,777 76, with two 12-month extension options in an estimated amount not to exceed \$238,888 88 per extension option, for a total estimated contract amount not to exceed \$955,555 52

**Amount and Source of Funding** Funding in the amount of \$218,981 51 is available in the Fiscal Year 2006-2007 Operating Budget of the Aviation Department Fund Funding for the remaining 13 months of the original contract period and extension options is contingent upon available funding in future budgets

**Fiscal Note** There is no unanticipated fiscal impact A fiscal note is not required

This contract is for inspection and repair services to the fire alarm and suppression systems at the Austin-Bergstrom International Airport (ABIA) The contractor will institute fire suppression, fire alarm and backflow prevention inspection, and routine maintenance schedule that includes inspection, testing, and repairs for the ABIA main terminal, parking garage, and various other buildings at ABIA This contract includes work that is beyond ABIA's maintenance staff's capabilities ABIA currently has no one on staff that is licensed by the State of Texas to maintain these types of safety systems
