Austin Energy is negotiating an agreement with Ballet Austin, to provide Austin Energy's chilled watercooling services to the Ballet Austin building located at 501 West Third Street, Austin, Texas

This RCA is to seek authorization for Austin Energy to complete the purchase of the heat exchanger and related piping. Austin Energy will recover the cost for these reimbursable items as a part of the multi-year chilled water services agreement negotiated between Austin Energy and Ballet Austin, Inc. To complete this project, Austin Energy will need to extend its district cooling system piping to this location, which will be accomplished through a separate piping installation contractor.
