MBE/WBE This contract was awarded in compliance with Chapter 2-9A of the City Code (Minority Owned and Women Owned Business Enterprise Procurement Program) This was an emergency service contract, therefore, it is exempted under Chapter 252 022 of the Texas Local Government Code and no goals were established for this solicitation

Boards and Commission Action Recommended by the Electric Utility Commission

Austin Energy (AE) determined the purchase of these civil construction services was a Critical Business Need to facilitate construction of AE's new Wells Branch Substation in Northwest Austin AE is constructing the substation in order to provide services to Hewlett-Packard's new data center facility and other office operations This contract will assist AE in meeting HP's requested timeline for energizing the substation by May 2007

This project provides for the initial steps towards construction of a 138kV electrical substation, which at completion will include installation of electrical equipment such as transformers, switchgear, and associated support structures The Wells Branch Substation will be located off Merriltown Road near Wells Branch Parkway

The work being performed under this contract consists of excavating the substation road and installing base material, and installing 770 feet of electric ductbank and four associated manholes

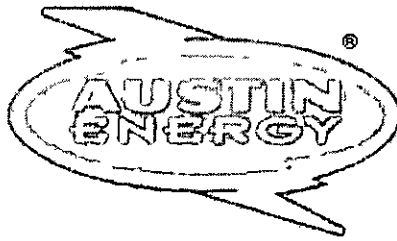

SUBJECT: Critical Business Need Substation Civil Construction to Serve Hewlett-Packard

ACTION


As detailed below, and in accordance with City Council-approved purchasing procedures, I am designating as a Critical Business Need of Austin Energy, the purchase of civil construction services from DPR Construction. We will bring an RCA to Council for ratification of this purchase next month.

BACKGROUND.

On May 17th, 2006, Austin Energy (AE) entered into an agreement with Hewlett Packard (HP) regarding services to their new facility in Northwest Austin. The agreement stipulated that AE would facilitate the construction of a substation for HP for their new data center off Merriltown Road. AE must implement a very tight schedule to meet HP's request to have this substation with its two transformers energized by May 2007.

DPR Construction is the prime contractor performing construction work for HP on the site in support of their new building. AE obtained from DPR a quote of \$220,000 to perform several tasks toward the civil construction of the substation, including excavating the substation road and installing base material, and installing 770 feet of electric ductbank and four associated manholes. With Purchasing's assistance, AE has reviewed the quote and deemed it reasonable and acceptable. Since the contractor is already mobilized to perform civil construction on the site, AE must take advantage of this opportunity to ensure the on-time completion of the station to meet our obligation to HP.
