MBE/WBE This contract will be awarded in compliance with Chapter 2-9A of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program) No subcontracting opportunities were identified, therefore, no goals were established for this solicitation

Boards and Commission Action Recommended by the Water and Wastewater Commission

The Four Points #1 Lift Station is located on Tahoe Parke Circle This lift station has a peak capacity of 2000 gpm and serves an area west of RM 620 and north of Bullick Hollow Road

Currently this lift station is experiencing the leakage of ground water into the station This leakage results in damage to the electrical and control equipment inside the stations

Approval of this request will authorize the replacement of the duct bank and the extension of the associated conduit into the station The contract includes provisions to thoroughly seal all openings

A contingency of approximately 9% has been added to the contract to address potential unknown conflicts that may arise during construction

The contract allows for 60 calendar days for the completion of this contract Bid documents were distributed to four contractors Bids were opened on October 5th, 2006 T Morales Electric & Controls Ltd submitted the lowest of the two bids received

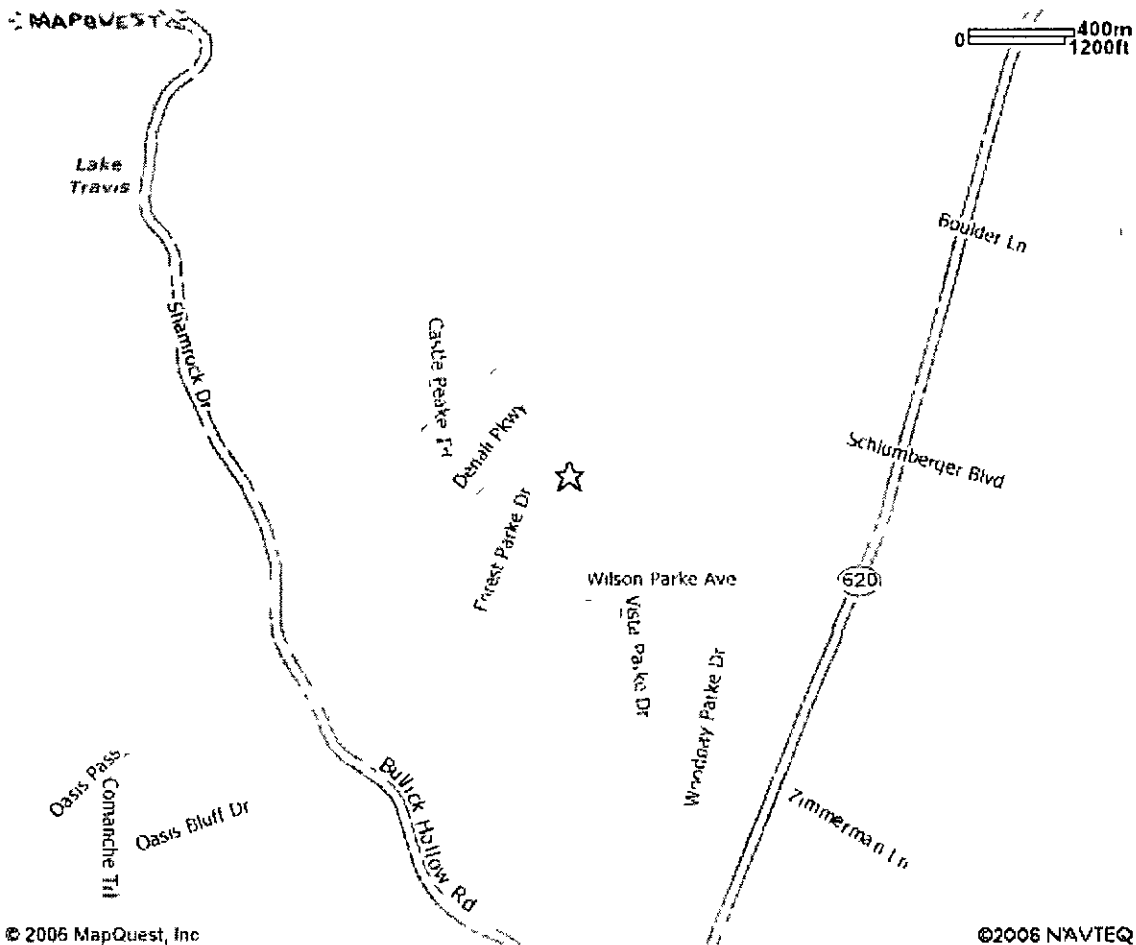
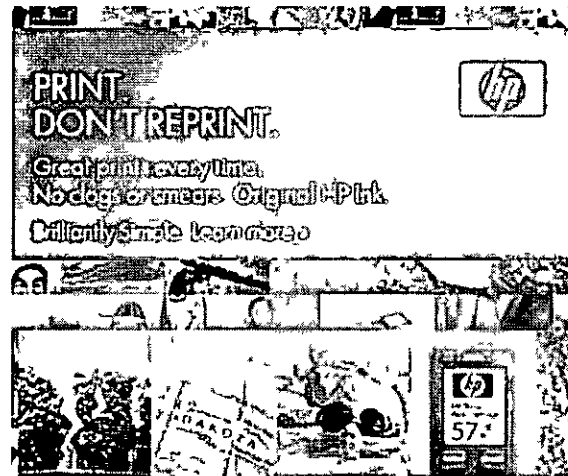


