Subject Approve an ordinance amending the Fiscal Year 2006-2007 Economic Growth and Redevelopment Services Office Operating Budget Special Revenue Fund of Ordinance 20060911-001 to appropriate funds to adopt a budget for the East Sixth Street Public Improvement District (PID) with a Beginning Balance of \$17,763, Revenue of \$86,588, and Requirements of \$82,588

Amount and Source of Funding \$2,306 in interest accrued in the PID account and late payments, and funding in the amount of \$41,214 is available through 2007 assessments (at a 89 92% collection rate), a \$43,500 contribution from the City of Austin, reduced by a \$432 shortfall in 2006 collections (Related to item #62)

Prior Council Action Approved the 2007 Service Plan and Budget and the 2007 PID assessment rate and proposed assessment roll on November 2, 2006, approved an ordinance on the 2006 assessments, adopting the assessment roll and levying assessments on November 30, 2006

This action amends the Economic Growth and Redevelopment Services Office Special Revenue Fund for the East Sixth Street Public Improvement District (PID) to account for 2007 assessment collections and contributions, and appropriate a budget for service delivery

Total projected revenue is \$86,588 This amount includes \$41,214 in 2007 assessments (at a 89 92% collection rate), \$2,306 in interest accrued in the PID account and late payments, and a \$43,500 contribution from the City of Austin, reduced by a \$432 shortfall in 2006 collections The appropriation of \$82,588 is for a contract with the Pecan Street Owners association to coordinate and subcontract for service enhancements in the East Sixth Street PID including public order/safety, physical improvements, marketing/public relations, and historic preservation The balance of the budgeted revenue, \$4,000 is a reserve to account for revenue adjustments made to the assessment roll

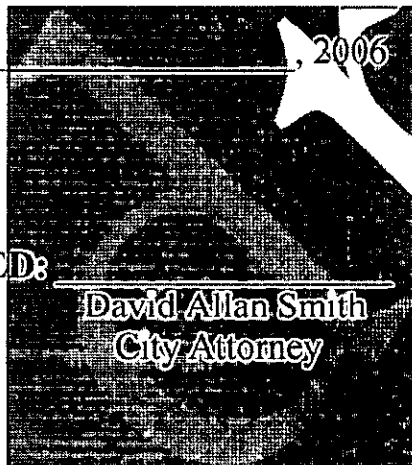
BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:
