**Subject:** Authorize award, negotiation, and execution of a 12-month requirements service contract with FALCON INSURANCE AGENCY, INC., Austin, TX, for aircraft liability and physical damage insurance coverage in an estimated amount not to exceed \$72,032, with two 12-month extension options in estimated amounts not to exceed \$79,235 for the first extension option and \$87,159 for the second extension option, for a total estimated contract amount not to exceed \$238,426.

**Amount and Source of Funding:** Funding in the amount of \$72,032 is available in the Fiscal Year 2006-2007 Operating Budget of the Austin Police Department. Funding for the extension options is contingent upon available funding in future budgets.
