Purchasing Language: Sole Source

This contract is for the purchase and installation of Wilsonstak library shelving for the Spicewood Springs Branch Library.

On November 3, 1998, the voters approved a bond issue for the design, construction, and furnishings for the expansion of the Spicewood Springs Branch Library. The expanded 13,257 square foot library will provide needed services for adults and children of the Spicewood Springs neighborhood and surrounding areas. The project includes space for check out, reference, children's programming, study and reading areas, automatic catalog accessing, Internet terminals, a Teen Center, and tutoring programs. It also includes other support functions such as a multipurpose room for large group meetings, restrooms, display area, offices, and storage rooms. Adequate parking and an exterior book drop are included as well.

School Specialty is the only authorized distributor of Wilsonstak Shelving for the Austin area. Wilsonstak Shelving was chosen by the Library Department in 1996 to be the standard for shelving. This decision was based on fiscal and public safety concerns related to the shelving requirements for large numbers of heavy books.

PRICE ANALYSIS a. Sole source. Fiscal and public safety concerns lead to the selection of this manufacturer's product in 1996 as the standard. For purposes of compatibility, this is a sole source purchase. b. The price offered represents a 32% increase from the last contract awarded May 2005. The increase is due to higher steel product prices and labor costs. **APPROVAL JUSTIFICATION** a. The Purchasing Office concurs with Austin Public Library Department's recommended award.
