
**Prior Council Action** 11/29/01 - Council approved an ordinance amending Section 25-1-46 of the City Code relating to the Land Use Commission 11/6/03 - Council approved a resolution directing the Planning Commission to consider neighborhood plans for the following neighborhoods Riverside, Pleasant Valley, Parker Lane, South River City, St Edwards, West Congress, East Congress and Sweetbriar 10/20/05 - Council directed the Planning Commission to consider neighborhood plans for the following neighborhoods South Lamar, Galindo, Zilker, Barton Hills, Windsor Park, University Hills, West Oak Hill, and Downtown

On November 29, 2001, the City Council approved an ordinance amending Section 25-1-46 of the City Code relating to the Land Use Commission. This ordinance provides that the Planning Commission act as the Land Use Commission for property wholly or partly within the following (1) the boundaries of an adopted neighborhood plan, (2) a proposed neighborhood plan on the effective date of a Council resolution or ordinance that directs the commission to consider the proposed plan, or (3) the former Robert Mueller airport

This action directs the Planning Commission to act as the Land Use Commission to consider neighborhood plans and the related land development applications for the following areas

Windsor Road/West Austin Neighborhood Group (WANG) North Lamar/Georgian Acres Windsor Hills/Heritage Hills St Johns/Coronado Hills
