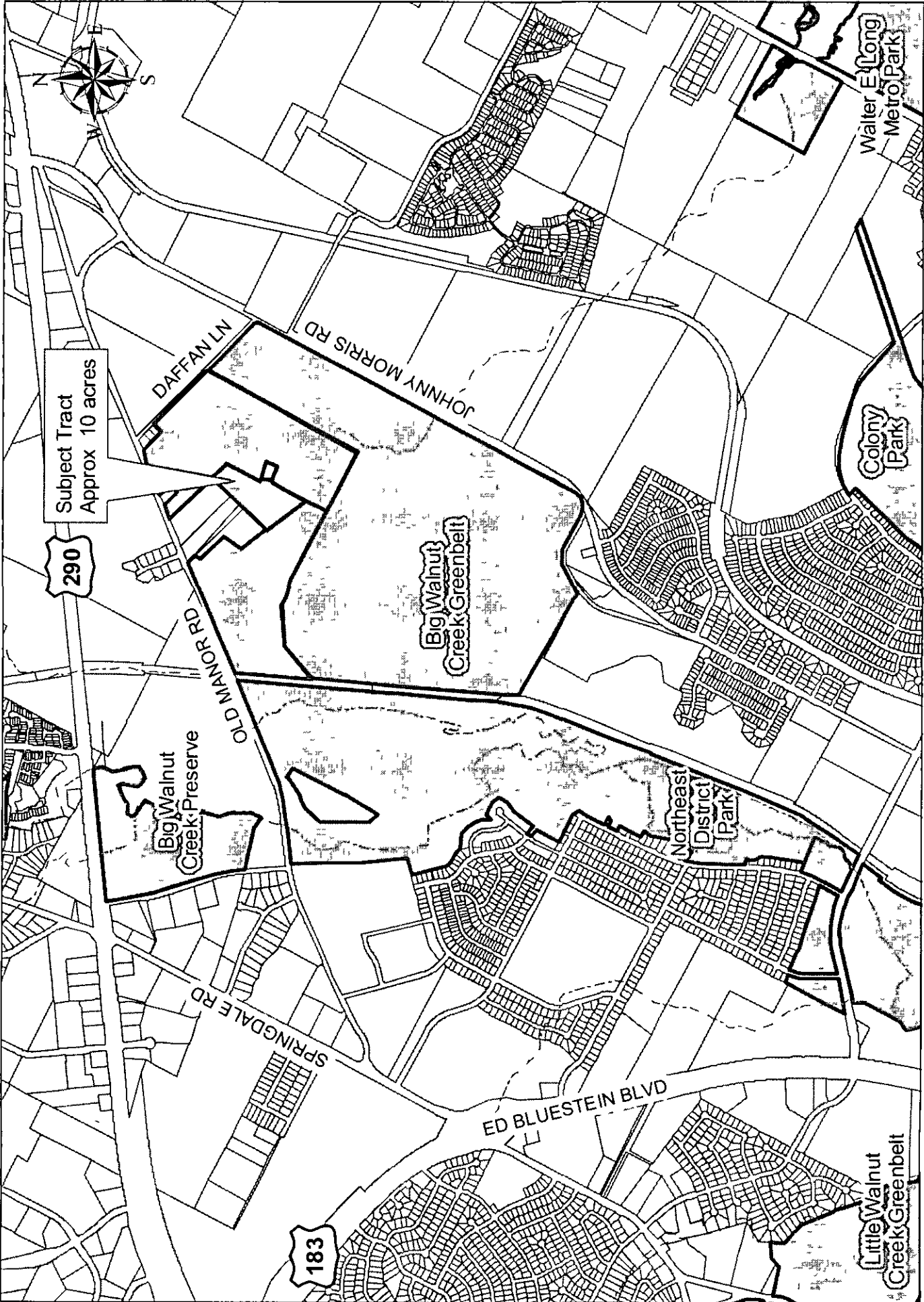

The November 1998 Bond Proposition 2 is to provide a number of parks, trails and recreation projects known as Greenway and Destination Parks. Greenways are corridors of public land along major creeks. Destination Parks are large, fully developed parks adjoining the greenways. The Greenway and Destination Parks will provide recreation, protect natural resources and water quality, and enhance the character of life in Austin.

This acquisition, adjacent to parkland recently acquired from the Ceder family, will add to an 841-acre park extending from the valley of Walnut Creek to the flat fields along Johnny Morris Road. This major park serving northeast Austin is the site of the new tennis center where construction will begin in spring 2007. The additional acquisition will provide space for future park facilities for families and team sports.

WHEREAS, the 10 acre tract located along Old Manor Road is adjacent to parkland recently acquired from the Ceder family, and will provide additional acreage to an 841-acre park extending from the valley of Walnut Creek to the flat fields along Johnny Morris Road, and

WHEREAS, the acquisition will provide additional Greenway Park space adjacent to the existing park along Johnny Morris Road, **NOW, THEREFORE,**

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

That the acquisition of the site is in furtherance of the purposes of November 1998 Bond Proposition Number 2 for Greenway and Destination Parks, and

That the City Manager is authorized to negotiate and execute a contract to purchase the 10 acre tract using proceeds from November 1998 Bond Proposition Number 2 for an amount not to exceed \$435,600 00 and on such other terms and conditions deemed appropriate by the City Manager
