

AUSTIN CITY COUNCIL MINUTES

REGULAR MEETING THURSDAY, NOVEMBER 2, 2006

Invocation: Dr. Jacquelyn Donald-Mims, founder and pastor, Imani Community Church, A.M.E

The following represents the actions taken by the Austin City Council in the order they occurred during the meeting. While the minutes are not in sequential order, all agenda items were discussed. The City Council of Austin, Texas, convened in a regular meeting on Thursday, November 2, 2006 in the Council Chambers of City Hall, 301 W. 2nd Street, Austin, Texas.

Mayor Wynn called the Council Meeting to order at 10:18 a.m.

CONSENT AGENDA

The following items were acted on by one motion. No separate discussion or action occurred on any of the items. The consent items were approved on Council Member Kim's motion, Council Member Martinez' second on a 7-0 vote.

1. Approval of the minutes of the Austin City Council from the regularly scheduled meeting of October 19, 2006.

The minutes from the regularly scheduled meeting of October 19,2006 were approved.

2. Approve negotiation and execution of Amendment No. 1 to the existing cost reimbursement agreement with SPGIL DOMAIN, L.P., previously known as The DOMAIN SHOPPING CENTER L.P. (Simon Properties), to increase the cost reimbursement in an amount not to exceed \$700,000 for underground utility piping and related equipment at the DOMAIN site, for a revised agreement total of \$4,900,000. Funding is available in the amount of \$700,000 in the Fiscal Year 2006-2007 Capital Budget of Austin Energy. Recommended by the Electric Utility Commission. The motion authorizing the negotiation and execution of amendment number 1 was approved.

Authorize Change Order No. 2 to increase the spending authorization for Austin Energy's Building

- 3. Authorize Change Order No. 2 to increase the spending authorization for Austin Energy's Building Purchase Agreement with DAUGHTERS OF CHARITY HEALTH SERVICES OF AUSTIN (d/b/a SETON HEALTH CARE NETWORK) to purchase from Seton a structure to house the necessary energy production equipment to serve the Dell Children's Hospital, in an amount not to exceed \$600,000, for a total not to exceed amount of \$5,700,000. Funding is available in the Fiscal Year 2006-2007 Capital Budget of Austin Energy. Recommended by the Electric Utility Commission. The motion authorizing change order number 2 was approved.
- 4. Authorize negotiation and execution of a professional services agreement with Deborah Mersky, Austin, TX, for artwork in the amount not to exceed \$60,000. Funding in the amount of \$60,000 is available through the Public Works Department in accordance with the Art in Public Places Ordinance. The Art in

Public Places Panel unanimously approved the artist's final design on September 11, 2006. The Arts Commission unanimously approved the artist's final design on September 18, 2006.

The motion authorizing the negotiation and execution of a professional services agreement was approved.

5. Authorize an Interlocal Agreement between the City and Travis County Emergency Services District Number 4 for firefighter certification training at a cost to the City not to exceed \$33,000. Funding in the amount of \$33,000 is included in the Fiscal Year 2006-2007 Operating Budget of the Austin Fire Department.

The motion authorizing an interlocal agreement was approved.

6. Authorize the negotiation and execution of professional service agreements with Smith, Robertson, Elliott & Glen, Austin, TX, in an amount not to exceed \$100,000 and with Scott Douglass and McConnico, L.L.P., Austin, TX, in an amount not to exceed \$150,000 for legal services related to the Water Treatment Plant 4, for a total amount not to exceed \$250,000. Funding in the amount of \$250,000 is available in the Fiscal Year 2006-2007 Capital Improvement Budget of the Austin Water Utility.

The motion authorizing the negotiation and execution of a professional service agreement was approved.

7. Approve an amendment to the legal services agreement with Demetrius McDaniel, Akin Gump Strauss Hauer & Feld LLP, Austin, TX, to provide legal services related to federal and state legislative matters, in an amount not to exceed \$90,000, for a total contract amount not to exceed \$165,000. Funding in the amount of \$90,000 is available in the 2006-2007 Operating Budget of Various General Fund and Enterprise Fund Departments.

The motion authorizing an amendment to the legal services agreement was approved. Council Member Cole abstained due to a conflict of interest.

- 8. Consider and set the Austin City Council meeting schedule for calendar year 2007. The motion authorizing the Austin City Council meeting schedule was approved.
- 9. Approve a resolution authorizing the negotiation and execution of an agreement with PB Austin Ridge L.L.C. and MF Austin Ridge L.L.C. to partially release the lien held by Travis County Health Facilities Development Corporation and the City on approximately 5.076 acres property located at 8509 FM 969 in exchange for PB Austin Ridge L.L.C. and MF Austin Ridge L.L.C.'s agreement to contribute land and a building for the Center for Child Protection. Resolution No. 20061102-009 was approved.
- 10. Authorize the negotiation and execution of a fee simple acquisition for the purchase of approximately 3.954 acres located along Spicewood Springs Road from Kenny Dryden for the Bull Creek Greenbelt in an amount not to exceed \$278,000. Funding is available in the Fiscal Year 2006-2007 Capital Budget of the Parks and Recreation Department.

The motion authorizing the negotiation and execution of a fee simple acquisition was approved.

11. Authorize execution of a construction contract with LAUGHLIN-THYSSEN, LTD, Houston, TX, for the Austin Clean Water Program: Little Walnut-Bridgeport/Fairfield Drive Wastewater Improvements Project in the amount of \$924,546, plus a \$46,227.30 contingency, for a total contract amount not to exceed \$970,773.30. Funding in the amount of \$970,773.30 is available in the Fiscal Year 2006-2007 Capital Budget of the Austin Water Utility. Lowest of five responsive bids received. 13.50% MBE and 8.54% WBE subcontractor participation. Recommended by the Water and Wastewater Commission. The motion authorizing the execution of a construction contract was approved.

12. Authorize execution of a construction contract with EXCEL CONSTRUCTION SERVICES, LLC, Austin, TX, for the Davis Water Treatment Plant – Process Improvements and Equipment Replacement/Rehabilitation Phase A, in the amount of \$2,224,000 plus an \$111,200 contingency, for a total contract amount not to exceed \$2,335,200. Funding in the amount of \$2,335,200 is available in the Fiscal Year 2006-2007 Capital Budget of the Austin Water Utility. Lowest of two bids received. 23.83% MBE and 0.02% WBE subcontractor participation. Recommended by the Water and Wastewater Commission.

The motion authorizing the execution of a construction contract was approved.

13. Authorize negotiation and execution of a professional services agreement with each of the following four firms: FREESE and NICHOLS, INC., Austin, TX, and H.R. GRAY, Austin, TX, for the Quality Assurance/Quality Control and Constructability Review Services Rotation List (2006-2009) for various Capital Improvement projects in the right-of-way; and FREESE and NICHOLS, INC., Austin, TX, and SUNLAND GROUP, Austin, TX, for the Quality Assurance/Quality Control and constructability Review Services Rotation List (2006-2009) for various site specific capital improvement projects. The maximum not to exceed amount of the agreements is \$400,000. The rotation lists are for a period of three years or until financial authorization is expended. Funding is available in the Fiscal Year 2006-2007 Operating Budget of the Public Works Department. Best two qualification statements of six statements received for the Site Specific Quality Assurance/Quality Control and Constructability Review Rotation List. Best two qualification statements of seven statements received for the Right-of-Way Quality Assurance/Quality Control and Constructability Review Rotation List. This contract will be awarded in compliance with Chapter 2-9B of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore no goals were established for this solicitation.

The motion authorizing the negotiation and execution of a professional services agreement was approved.

15. Approve an ordinance amending Section 12-4-24 of the City Code to establish a maximum speed limit of 25 miles per hour on residential streets within the area bounded by Barton Springs Road, Robert E. Lee Road, Rabb Road, Rae Dell Avenue, Barton Skyway, and South Lamar Boulevard. Funding in the amount of \$4,500 is available in the Fiscal Year 2006-2007 Operating Budget of the Public Works Department for installation of necessary signs. Ordinance No. 20061102-015 was approved.

16. Approve an ordinance amending Section 12-4-24 of the City Code to establish a maximum speed limit of 25 miles per hour on residential streets within the area bounded by South Congress Avenue, West Oltorf Street, South First Street, Barton Springs Road and West Riverside Drive. Funding in the amount of \$3,500 is available in the Fiscal Year 2006-2007 Operating Budget of the Public Works Department for installation of necessary signs. Ordinance No. 20061102-016 was approved.

17. Approve an ordinance amending Section 12-4-24 of the City Code to establish a maximum speed limit of 25 miles per hour on Sunset Trail and West Wind Trail. Funding in the amount of \$600 is available in the Fiscal Year 2006-2007 Operating Budget of the Public Works Department for installation of necessary signs.

Ordinance No. 20061102-017 was approved.

18. Authorize award, negotiation and execution of a contract with SQUARE D SCHNEIDER ELECTRIC SERVICES, Houston, TX, for the purchase of a 480-volt load center at the Decker Creek Power Station

in an amount not to exceed \$279,160. Funding is available in the Fiscal Year 2006-2007 Capital Budget of Austin Energy. Best evaluated proposal of three proposals received. This contract will be awarded in compliance with Chapter 2-9D of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

The motion authorizing the negotiation and execution of a contract was approved.

19. Authorize award and execution of a contract with SQUARE D SCHNEIDER ELECTRIC SERVICES, Houston, TX, for the purchase and installation of a 480-volt electrical switchgear system in an amount not to exceed \$800,000. Funding is available in the Fiscal Year 2006-2007 Capital Budget of Austin Energy. Sole Source This contract will be awarded in compliance with Chapter 2-9D of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation. The motion authorizing the award and execution of a contract was approved.

The motion authorizing the award and execution of a contract was approved.

20. Authorize award and execution of a 24-month requirements service agreement with ANACON INC., Houston, TX, to provide priority and regulated pollutant analysis services for the Austin Water Utility in an amount not to exceed \$460,000, with two 12-month extension options in an estimated amount not to exceed \$230,000 per extension option, for a total estimated contract amount not to exceed \$920,000. Funding in the amount of \$230,000 is available in the Fiscal Year 2006-2007 Operating Budget of the Austin Water Utility. Funding for the remaining 12-months of the initial contract period and extension options will be contingent upon available funding in future budgets. Lowest bid of three bids received. This contract will be awarded in compliance with Chapter 2-9C of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore no goals were established for this solicitation.

The motion authorizing the award and execution of a requirements service agreement was approved.

- 21. Authorize award and execution of a contract with ITT FLYGT CORP., Cedar Park, TX, for the purchase of a submersible pump for the Austin Water Utility in an amount not to exceed \$53,711. Funding is available in the Fiscal Year 2006-2007 Operating Budget of the Austin Water Utility. Lowest bid of two bids received. This contract will be awarded in compliance with Chapter 2-9D of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore no goals were established for this solicitation. The motion authorizing the award and execution of a contract was approved.
- 22. Authorize award and execution of two 12-month requirements service agreements with PAMPERED LAWNS AUSTIN, INC., Austin, TX, in an estimated amount not to exceed \$82,074, with two 12-month extension options in an estimated amount not to exceed \$82,074 per extension option, for a total estimated contract amount not to exceed \$246,222; and with WILLIAMSON LAND DEVELOPMENT (MBE/MB), Cedar Park, TX, in an estimated amount not to exceed \$85,924, with two 12-month extension options in an estimated amount not to exceed \$85,924 per extension option, for a total estimated contract amount not to exceed \$257,772, to provide ground maintenance services for various locations throughout the Austin Water Utility. Funding in the amount of \$167,998 is available in the Fiscal Year 2006-2007 Operating Budget of the Austin Water Utility. Funding for the remaining options will be contingent upon available funding in future budgets. Lowest bids of eight bids received. This contract will be awarded in compliance with Chapter 2-9C of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting Opportunities were identified; therefore no goals were established for this solicitation.

The motion authorizing the award and execution of two requirements service agreements was approved.

- 23. Authorize award and execution of a 24-month requirements supply contract with PLANT EQUIPMENT & SERVICE, INC., Bryan, TX for the purchase of epoxy cement manhole seal surface kits for the Austin Water Utility in an estimated amount not to exceed \$118,200, with two 12-month extension options in an estimated amount not to exceed \$73,875 per extension option, for a total estimated contract amount not to exceed \$265,950. Funding in the amount of \$54,175 is available in the Fiscal Year 2006-2007 Operating Budget of the Austin Water Utility. Funding for the remaining 13 months of the initial contract period and extension options is contingent upon available funding in future budgets. Lowest bid meeting specifications of two bids received. This contract will be awarded in compliance with Chapter 2-9D of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation. The motion authorizing the award and execution of a requirements supply contract was approved.
- 24. Authorize award and execution of a 24-month requirements service contract with KIL-A-BUG PEST CONTROL, Austin, TX, for pest control services in an estimated amount not to exceed \$126,632, with two 12-month extension options in an estimated amount not to exceed \$63,316 per extension option, for a total estimated contract amount not to exceed \$253,264. Funding in the amount of \$58,040 is available in the Fiscal Year 2006-2007 Operating Budget of the Finance and Administrative Services Department, Building Services Division. Funding for the remaining 13 months of the original contract period and extension options is contingent upon available funding in future budgets. Lowest bid of six bids received. This contract will be awarded in compliance with Chapter 2-9C of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

The motion authorizing the award and execution of a requirements service contract was approved.

25. Authorize award and execution of a contract through the Texas Multiple Award Schedule (TXMAS) with SOUTHWEST SOLUTIONS GROUP, Round Rock, TX, for the purchase of various evidence storage shelves for the Austin Police Department in an amount not to exceed \$100,115.65. Funding is available in the Fiscal Year 2006-2007 Capital Budget of the Finance and Administrative Services Department, Building Services Division. Cooperative Purchase

The motion authorizing the award and execution of a contract was approved.

26. Authorize award, negotiation, and execution of a 12-month requirements service contract with PUBLIC SOLUTIONS GROUP, LTD., Grapevine, TX for alternative fuel consulting services in an estimated amount not to exceed \$114,367, with two 12-month extension options in an estimated amount not to exceed \$114,367 per extension option, for a total estimated contract amount not to exceed \$343,101. Funding in the amount of \$104,836.42 is included in the Fiscal Year 2006-2007 Operating Budget of the Financial and Administrative Services Department, Fleet Fund. Funding for the remaining one month of the original contract period and extension options is contingent upon available funding in future budgets. Best evaluated proposal of three proposals received. This contract will be awarded in compliance with Chapter 2-9C of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program). No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.

The motion authorizing the award, negotiation, and execution of a requirements service contract was approved.

27. Authorize award and execution of an 11-month requirements supply contract through U.S. Communities Government Purchasing Alliance with HAGEMEYER NORTH AMERICA, Charleston, SC, for the purchase of Level A Hazmat suits and supplies in an amount not to exceed \$74,045, with two 12-month extension options in an estimated amount not to exceed \$35,000 per extension option, for a total estimated contract amount not to exceed \$144,045. Funding in the amount of \$74,045 is available in the

State of Texas, Governor's Division of Emergency Management, 2005 Homeland Security Grant program. Funding for the extension options is contingent upon available funding in future budgets. Cooperative Purchase.

The motion authorizing the award and execution of a requirements supply contract was approved.

28. Authorize award and execution of Amendment No. 4 to the contract with EMANCIPET, INC., Austin TX, for spay/neuter pet services for low-income residents of Austin to increase the current contract in an estimated amount not to exceed \$54,000 per year; and to increase the remaining extension option in an estimated amount not to exceed \$54,000, for a revised total agreement amount not to exceed \$456,000. Funding in the amount of \$54,000 is available in the Fiscal Year 2006-2007 Operating Budget of the Health and Human Services Department. (General Fund, \$40,000; Donation Accounts, \$9,000; and Travis County, \$5,000). Funding for the remaining extension option is contingent upon available funding in future budgets. 14. Approve an ordinance amending Chapter 12-1 of the City Code to add Article 6 relating to automated red light enforcement.

Ordinance No. 20061102-014 was approved with the following directions to staff on Council Member Martinez' motion, Council Member Kim's second on a 7-0 vote. Council Member Kim's direction to staff was: 1) the implementation timeline should include a bilingual public awareness and education campaign; 2) there should be subcontracting opportunities for local women and minority-owned businesses for the public awareness and education campaign; 3) dangerous intersections that have close calls and not just a high frequency in accidents should be included; 4) preliminary statistics should be released at the three month mark and an in-depth report submitted after six months; 5) the current statistics should be set as the baseline for violations and crashes at the 15 intersections selected; and 6) the ordinance language regarding the Traffic Safety Fund Account should be broad enough to encompass all of the safety and traffic projects under which the city could benefit.
