This budget amendment will enable the immediate purchase of 100 various software licenses that are required to support new users and functions at the Municipal Court, including the new juvenile case manager program, expansion of Central Booking magistration for use on 24-hour a day/seven days a week basis, the court management system, imaging scanners, electronic signature pads, credit card pads, and the changes inherent to the process of migrating from a paper-based to an electonic records system. Funds will also provide additional maintenance costs associated with these licenses.
