

The City is acquiring a fire station site for the Avery Ranch Davis Springs area as requested by the Austin Fire Department. The request was for the acquisition of a three-acre site for the proposed fire station to be located at or near the Parmer Lane and Spectrum Drive intersection. The owner of the 2-68 acre tract is asking \$10 per square foot for the property, or a total asking price of \$1,167,408. An independent third-party appraisal was requested to established the fair-market value of the proposed acquisition.
