The Transportation Division of the Public Works Department has completed an investigation on Harrisglenn Drive in the vicinity of Dessau Elementary School, Delco Primary School, and Dessau Middle School. Traffic volumes, vehicle speeds, and pedestrian volumes and patterns were evaluated in order to determine what modification, if any, could be made to improve the safety of the students attending Dessau Elementary School, Delco Primary School, and Dessau Middle School

As a result of this investigation staff recommends installing a school zone on the following streets

Harrisglenn Drive from 200 feet south of Josh Ridge Drive to 200 feet north of Josh Ridge Drive (Dessau Elementary School, Delco Primary School, and Dessau Middle School)

PART 2. The amendments made in this ordinance shall be incorporated in alphabetical order and the existing subsections renumbered accordingly




