Purchasing Language Cooperative Purchase

MBE/WBE This contract will be awarded in compliance with Chapter 2-9D of the City Code (Minority-Owned and Women-Owned Business Enterprise Procurement Program) No subcontracting opportunities were identified, therefore, no goals were established for this solicitation

This contract is for the purchase and installation of a standard precast combination shower and flush toilet facility for Big Stacy Pool. The Big Stacy Pool and the existing restrooms and showers were built during in the 1940's. In the mid 1990's, renovations to the pool area were performed. However, due to funding constraints, the restrooms and the showers could not be upgraded at that time. The new pre-fabricated restrooms and showers will fully comply with current ADA requirements and will accomplish a top priority for the area's neighborhood association.

This cooperative purchasing program is established by the Texas Building and Procurement Commission. It allows the City to use TXMAS contracts that have been developed from contracts that were competitively bid and awarded by the General Services Administration's Federal Supply Service.
