**Subject:** Type 2 Short Term Rental License Applications Report

As a result of City Council action on November 13, 2015, Austin Code is not issuing any licenses on Type 2 short term rental applications received after November 12, 2015. The existing license applications have been placed into two groups based on the dates of submission to the department:

- Group 1 Applications received prior to September 17, 2015 This group will be reviewed in accordance with standard review procedures and time limits.

- Group 2 Applications received between September 17, 2015 and November 12, 2015 inclusive. The cutoff for issuance of licenses for this group is November 23, 2015. Staff is reaching out to each of the applicants to insure that they are aware of the deadline for issuance and the urgency of completing their application packages.
