Violent Crime Initiative Downtown Austin

The purpose of this memorandum is to provide information on Austin Police Department's (APD) plan to address the significant increase in violent crime that has taken place in our downtown this year. While violent crime is down citywide, the increases in aggravated assault and robbery in the Downtown Area Command (DTAC) over this past year, along with the recent high profile shooting incidents, require some immediate changes to APD's operations. Since the beginning of 2019 there have been 107 aggravated assault incidents downtown with 28 of those being shooting incidents. In addition, there have been 19 stabbings, 22 arrests for unlawfully carry of a weapon, and 10 felons in possession of a firearm. Additionally, APD has seen the responsibilities assigned to DTAC personnel significantly increase over the past several years as the "entertainment district" has expanded to include West 6th street, East 6th street east of the Interstate, Rainey Street, the Red River district, and expansions to the 4th Street entertainment venues. While APD has not reduced the number of officers within DTAC, their geographic area of responsibilities have increased so much that the officers are spread extremely thin at times.

To achieve a safer downtown and address the increase in violence, APD began an initiative last week that has DTAC officers working a smaller geographical area and utilizing bike patrols to the greatest extent possible. This will increase visibility and mobility within the district. During this initiative, the adjacent sectors will assume responsibility for the areas outside the focus area of this initiative. DTAC will maintain full staffing during this initiative and the adjacent sectors will adjust staffing as necessary to handle their additional responsibilities.

In addition to these patrol resources, support units from Organized Crime (Street Narcotics and the Gang Unit), Mounted Unit, Metro Tactical Units, Real Time Crime Center (HALO-Public Safety Cameras), and Air Support will assist in the initiative. Texas DPS also volunteered to assist and will be working traffic in the downtown area and downtown IH35.

APD portable light trailers (2) are currently deployed in strategic locations inside the target area to improve lighting in areas where that may impact crime.

APD will monitor the impacts of the initiative and will shift or add resources as needed. The initiative began on August 1, 2019 and our department has seen positive impacts within the target area.

Our planning effort highlighted the need for our department to re-evaluate the geographic boundaries and the staffing needs for DTAC. APD will be working on long-term strategies to address the changes within the downtown area.

Summary of Activity from August 1st through August 5th:

- Officers handled 605 calls for service, 69% were self-initiated (416 self-initiated vs. 189 dispatched).
- There have been 90 reports written with 45 arrests. Narcotics-related arrests (13) are the highest, followed by public intoxication (6) and requests to apprehend-warrant (5).

We will continue to track data throughout this initiative, to include violent crime trends and gun crimes/seizures.
