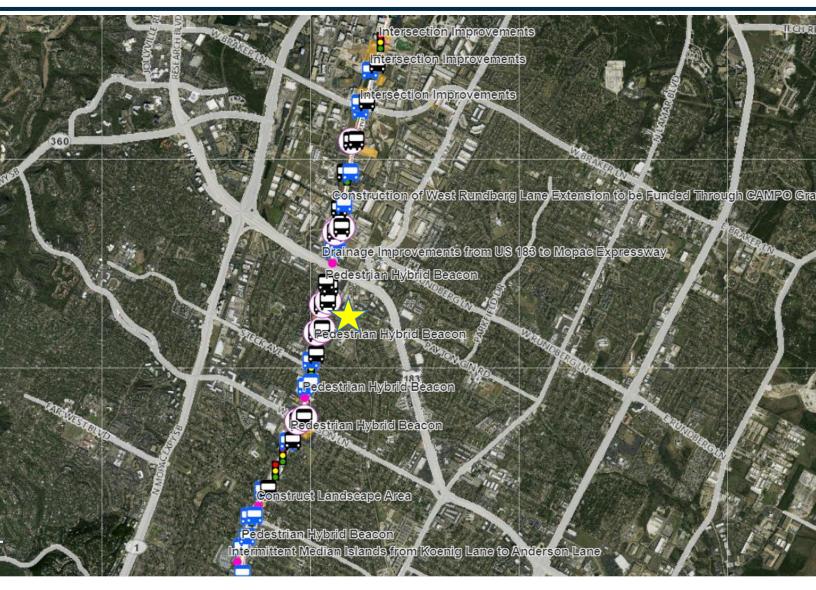

Polaris Avenue Flats CRP – Burnet Rd / N. Lamar Corridor Mobility Plan



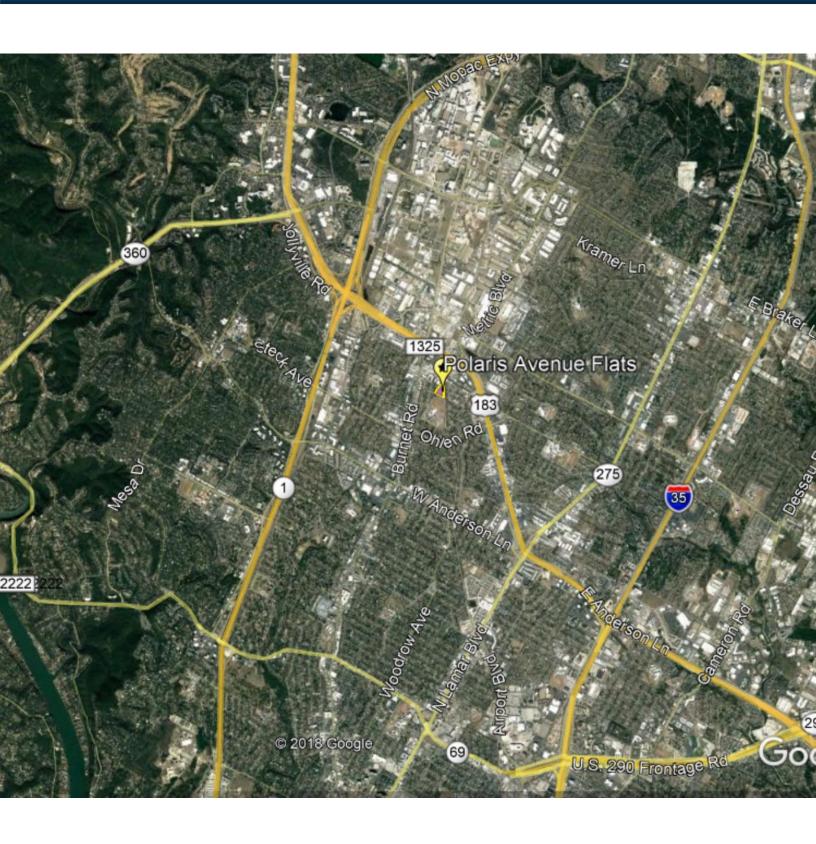

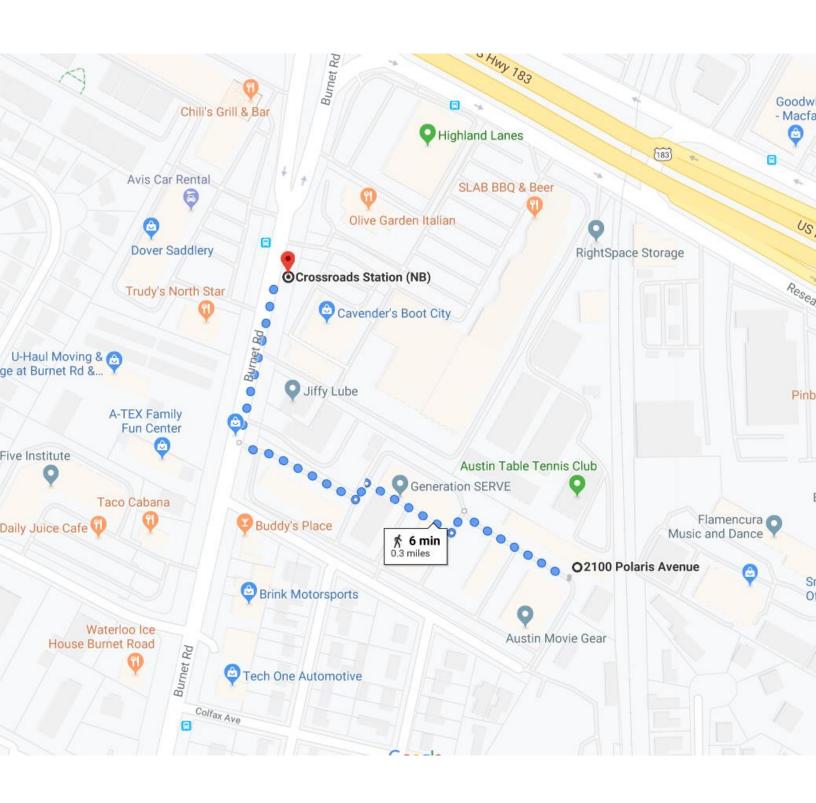
