

Business or Venue Type	Prohibitions Per Order as of March 21, 2020
Arena (Indoor and Outdoor)	No social gatherings of more than 10 people. For gatherings that are not of a social nature (e.g., employment related) social distancing must be maintained and controlled.
Auditorium	No social gatherings of more than 10 people. For gatherings that are not of a social nature (e.g., employment related) social distancing must be maintained and controlled.
Bar	Closed by Austin and Travis County Order until May 1, 2020.
Business	Unless the business is exempt (e.g., grocery stores) then any gathering of more than 10 people not of a social nature (e.g., employment related) must maintain and control social distancing.
Business Cafeteria	Take away only. Recommended to stagger lunch breaks.
Child Care or Day Care Facility	Exempt. Includes family-home or center-based childcare facilities.
Common Area	No more than 10 - social distancing recommended. Social gathering of more than 10 is prohibited. Gathering of more than 10 that is not social in nature must maintain social distancing.
Community Gathering	No more than 10 - social distancing recommended. Social gathering of more than 10 is prohibited. Gathering of more than 10 that is not social in nature must maintain social distancing.
Conference Center	No more than 10 - social distancing recommended. Social gathering of more than 10 is prohibited. Gathering of more than 10 that is not social in nature must maintain social distancing.
Confined Space (Indoor or Outdoor)	No more than 10 - social distancing recommended. Social gathering of more than 10 is prohibited. Gathering of more than 10 that is not social in nature must maintain social distancing.
Construction Sites	Unless the business is exempt (e.g., grocery stores) then any gathering of more than 10 people not of a social nature (e.g. employment related) must maintain and control social distancing.
Convenience Store	Exempt - Social distancing recommended.
Cosmetology	Unless the business is exempt (e.g., grocery stores) then any gathering of more than 10 people not of a social nature (e.g. employment related) must maintain and control social distancing. Massage parlors are the only subcategory mandated to close by statewide Orders.
Critical Facility	Exempt. Critical infrastructure includes airport facilities and operations, transit, transit facilities, and financial institutions; government buildings providing essential services; any schools or institutes of higher learning (if in operation), family home- or center-based childcare facilities; grocery stores and pharmacies; hospitals and medical offices and facilities, and veterinarian services; and homeless shelters, homeless encampments, and any nonprofit community establishment, whether part of or separate from a homeless shelter, providing food in a dining facility to the indigent.
Critical Infrastructure	Exempt and ORDERED to continue operating. Includes banking and financial institutions; transit and transit facilities, transportation services, equipment and facilities; power, water, telecommunications, natural gas, and public utilities; critical manufacturing including components for primary metals, machinery, electrical equipment and components, health and safety products and equipment, and transportation equipment; auto and vehicle parts manufacturing and assembly plants; technology manufacturing companies; information and communications, including press; emergency services; public health and medical services; fire and law enforcement; public works; agriculture and food; airport facilities and operations; sanitation services; other City government buildings or facilities, as designated by the City Manager. Strongly recommended to implement employee protections.
Event Center	No social gatherings of more than 10 people. For gatherings that are not of a social nature (e.g., employment related) social distancing must be maintained and controlled.
Event Venue	No social gatherings of more than 10 people. For gatherings that are not of a social nature (e.g., employment related) social distancing must be maintained and controlled.
Gathering	No more than 10 - must comply with social distancing if it is not a gathering of a social nature. Social gatherings of more than 10 are prohibited.
Grocery Store	Exempt.
Gyms	Closed by statewide order until April 3, 2020.
Healthcare Facilities	Exempt. Considered Critical infrastructure.
Homeless Shelters	Exempt.
Lodging Establishment	Unless the business is exempt (e.g., grocery stores) then any gathering of more than 10 people not of a social nature (e.g. employment related) must maintain and control social distancing. Social gatherings of more than 10 are prohibited.
Mall	No more than 10 - must comply with social distancing if it is not a gathering of a social nature. Social gatherings of more than 10 are prohibited.
Manufacturing	Exempt - Social distancing recommended.
Massage Parlor	Closed by statewide order until April 3, 2020.
Meeting Hall	No social gatherings of more than 10 people. For gatherings that are not of a social nature (e.g., employment related) social distancing must be maintained and controlled.
Movie or Live Theatre	Unless the business is exempt (e.g., grocery stores) then any gathering of more than 10 people not of a social nature (e.g. employment related) must maintain and control social distancing. Social gatherings of more than 10 are prohibited. Effectively closed to the public.
Movie Theatre (Drive-In)	Drive-in theatres permitted. Patrons should stay within their cars and social distancing recommendations apply.
Nightclub	Closed by Austin and Travis County Order until May 1, 2020.
Nursing Homes, Retirement and Long-Term Care Facilities	By statewide Order, people shall not visit nursing homes or retirement or long-term care facilities unless to provide critical assistance until April 3, 2020.
Parks (Public)	Public parks are currently open. Exercise is encouraged - social distancing recommendations apply. Austin Nature and Science Center, Zilker Botanical Garden, Mayfield Park and Perserve are all closed along with pools and recreation centers.
Party	No more than 10 - social distancing recommended. Parties of more than 10 people are prohibited.
Pharmacy	Exempt.

Business or Venue Type	Prohibitions Per Order as of March 21, 2020
Place of Worship	No more than 10 - social distancing recommendations apply. Gathering of more than 10 people is prohibited.
Pools (Public)	Closed with non-essential public facilities.
Private Property	No more than 10 - social distancing recommendations. Social gathering of more than 10 people is prohibited. Gathering of more than 10 people for a non social purpose must maintain social distancing. Certain private properties (e.g. grocery stores) are exempt.
Public Property	See Private Property. Certain public property is exempt (e.g.. Government buildings providing essential services).
Restaurant	Dining-in closed by Austin and Travis County Order until May 1, 2020. Take-away service only for customers. No more than 10 employees in front of house, and no more than 10 employees in back of house at the same time.
Restaurant Outdoor Patios	Closed by Austin and Travis County Order until May 1, 2020.
Retail Outlet	May be exempt depending on the nature of the retail outlet. Permitted retail outlets include grocery stores, pet food stores, warehouse stores, big-box stores, bodegas, gas stations, farmers' markets, or food pantries that provide or sell food products or household staples. Otherwise gatherings of more than 10 people of a non social nature are permitted if social distancing is maintained.
School	Closed by statewide order until April 3, 2020. Otherwise, exempt and up to district discretion.
Social / Physical Distancing	Defined as maintaining and controlling a minimum of six feet of separation between people other than during incidental and momentary passing.
Social Gatherings / Special Events	No more than 10 - social distancing recommendations apply. Social gatherings include, but are not limited to, weddings, religious services, parties, funerals, sporting events, social events, conferences, and meetings. Social gatherings of more than 10 people are prohibited under Orders.
Soup Kitchen	Exempt.
Sport Facility	No more than 10 - social distancing recommended. Social gathering of more than 10 is prohibited. Gathering of more than 10 that is not social in nature must maintain social distancing.
Warehouse	Exempt. Social distancing recommended.
