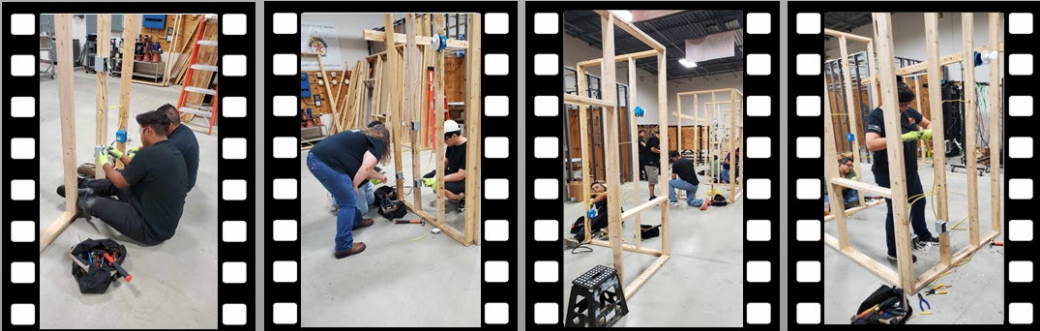

Loan Star Construction Trades Training conducted a free 40-Hour Electrical Training Course for individuals considering a career as an Electrician. Through classroom instruction, students learned basic electrical theory, electrical code, blueprint reading, and tool safety. Students then applied what they learned in the classroom, to the hands-on portion of training which included: wiring of switches, GFCI receptacles, 3-way switches, duplex receptacles, conduit bending, and wiring a panel. Upon completion of the course, students received a State of Texas Apprenticeship License, a tool bag filled with electrician hand tools, OSHA-10 certification, and endless opportunities to pursue a career they previously may have never realized possible.

Owners, and lead instructors, Rebecca Young and Darci Brennan have 52-years combined experience in the Electrical Trades Industry and believe being on time, taking initiative, and having a great attitude is the key to a trainee's success. When asked what they would tell someone who is considering a career in the construction industry, Rebecca stated: "the construction industry is booming, so applying to a DOL-Approved Apprenticeship Program is a great way to earn as you learn". Darci went on to further explain that "Apprenticeships are the best kept secret because it allows trainees the opportunity to learn through schooling and on-the-job training while receiving great pay and benefits".
