
Community Tree Preservation Benefits of Service

- Community Health and Well-being Austin's trees enhance our day-to-day lives by enriching our experiences and sense of place, inciting better health, aiding in tourism, recruitment of businesses, ecosystem sustainability, and amplifying our connection to our community.
- The U.S. Forest Service performed the first ever urban forest inventory and analysis report in Austin (2014) and found that trees in Austin:
 - Store approximately 1.9 million tons of carbon (valued at \$242 million)
 - Reduce annual residential energy costs by an estimated \$18.9 million per year
 - Reduce storm water runoff by an estimated 65 million cubic feet per year

- 1. Appropriate urban forest management is contingent upon recognizing economic and climatic fluctuations and related impacts
- Interdepartmental coordination ensuring urban forest management consistencies
- Continually enhancing community outreach promoting education and the benefits of the urban forest

Technology Fund

The DSD technology fund provides the means for improving service delivery through continuous technology enhancements for both Development Services and Planning and Zoning. The fund supports the implementation of new solutions such as the Austin Build+Connect online portal for permitting and the new Electronic Plan Review system. Other projects include replacing the unsupported legacy systems for Underground Storage Tank and Fiscal Surety business units, adding the new Qless online service request system, adding new and updating existing business processes in the AMANDA application, and improving communication through digital media.


