












## CAPITAL PROGRAM 2012 G.O. BOND PROGRAM



### Austin History Center Interior & Exterior Improvements

#### Scope:

Infrastructure upgrades at the three-storied Austin History Center will include wheel chair lift replacements, lead-based paint and asbestos abatement, demolition and replacement of worn finishes, retrofits of lighting and other electrical elements along with restoration of the exteriors to redress structural issues and restore aesthetic appeal of the loggia fresco.

Estimated Completion Date: February 28, 2019

## CAPITAL PROGRAM 2012 G.O. BOND PROGRAM

### Pleasant Hill Branch Library Roof Replacement & HVAC Upgrade

#### Scope:

The failing roof and HVAC system are original equipment dating from the time of construction (1986) and both will be replaced to restore the integrity of the building against water penetration and restore interior climate control. The roof replacement will consist of removal of the existing roof system under asbestos abatement protocol and the installation of a new roofing system to include insulation, raised curbs, modified bitumen membrane, flashing, gutters, downspouts, incidental siding and associated electrical and plumbing work. The HVAC Upgrade will consist of the removal of the existing air-conditioning units, furnace, and open area supply diffusers and installation of new air-conditioning and heating units with modifications to the supply and return ductwork of each unit, addition of gas piping and new sidewall supply air devices in the open areas.


## CAPITAL PROGRAM 2012 G.O. BOND PROGRAM

### Will Hampton Branch Library Renovation

#### Scope:

The renovation of the Will Hampton Branch Library at Oak Hill will include a full replacement of the deteriorated roof, worn interior and exterior finishes, aged furniture, plumbing and lighting fixtures along with other obsolete equipment as well as a retrofit of the building's mechanical (HVAC) system.

Estimated Completion Date: November 28, 2018

## CAPITAL PROGRAM 2012 G.O. BOND PROGRAM

### Zaragoza Warehouse Sprinkler Retrofit

#### Scope:

To meet current building and life safety codes, the project will retrofit the forty-seven year old fire suppression sprinkler system at the 20,000 square foot Zaragoza Warehouse, the Library Department's only storage facility. The work will include demolition of a traditional wet-pipe system with some dry-pipe elements and new construction of a special application sprinkler system for commodity storage/general warehousing, including low pressure, dry/pre-action valves, electric fire pumps and flexible drops to accommodate changes in occupied areas.

## CAPITAL PROGRAM 2012 G.O. BOND PROGRAM

### Cepeda Branch Library Renovation

#### Scope:

The project consists of interior and exterior improvements to restore this heavily used branch to operational standards. The work will include demolition and replacement of floor and wall finishes, repair of the slab-on-grade foundation, drywall assemblies, mechanical assemblies, suspended ceilings, and exterior cement plaster (stucco).

### Yarborough Branch Library Renovation

#### Scope:

The Yarborough Branch Library occupies the former Americana Theatre building constructed in 1965. The project's interior and exterior improvements will renew the faded interiors, deteriorated furnishings and failed equipment. The work will include miscellaneous asbestos abatement and the replacement of storefront window systems, electrical service and new electrical and plumbing fixtures.

Estimated Completion Date: March 29, 2018

### Windsor Park Branch Library Renovation

#### Scope:

The project will restore this community library to original design conditions by replacing deteriorated wall and floor finishes, worn furniture and failing equipment. New lighting systems, new suspended, acoustical ceilings and extensive repairs to the exterior portland cement (stucco) walls are included in the project scope.

Estimated Completion Date: June 25, 2018

### University Hills Branch Library Parking Lot Expansion


#### Scope:

The project provides for the land acquisition, design and construction of a new, asphalt parking lot with 25 parking spaces to better accommodate the number of customers at this busy branch library. The work will also include the selective demolition of existing structures and pavement, construction of walkways, a water quality pond, installation of landscaping and lighting and an Art in Public Places exterior sculpture piece.

Estimated Completion Date: December 28, 2018






# 2018 G.O. BOND PROPOSAL PROGRAM **New Facilities**

#### **Resource Libraries (4)** \$65.2M

shall be approximately 30,000 SF each located in each guadrant of the City to bridge and to strengthen support to existing branch libraries. Resource Libraries will augment public services and will serve as BRANCH administrative and staff support centers, linking clusters of branches in each area of the City. These facilities will provide expanded collections, additional services and meeting room spaces for the public. In addition, the Resource library facilities will provide workspace for staff in the areas of reference, youth services and information technology.

John Henry Faulk Library (2 floors only)







Modify the second and third floors of the Faulk Central Library to meet minimal archival storage standards by removing existing carpet and providing a sealed, epoxy-coated concrete flooring finish.

Following the New Central Library's opening in 2016, the Faulk Central Library (800 Guadalupe St.) will be renovated to serve as an archival repository and exhibition display annex for the adjacent Austin History Center (810 Guadalupe St.).
