In 2011, Mayor Lee Leffingwell and City Council members by way of a Council Resolution directed the City of Austin to create the Austin Youth Council (AYC). This was a focused way to bring Austin's youth into civic engagement. When AYC began it was made up of 14 Austin-area high schools with 25 members from the schools represented. AYC has grown to over 25 schools representing 80 members. In 2015 Mayor Steve Adler and City Council has continued to lead the city council in support the efforts of AYC.

In 2014, the City of Austin changed from an at-large system with seven council members to a single district 10-1 system which was voted on by Austin residents. This change was established to increase equitable participation on the City Council dais allowing an elected council member to voice and advocate their constituents' concerns. AYC mirrors this 10-1 system with an elected member from each of the 10 districts. Elected members are voted into their position at the end of the school year to serve the upcoming school year.

AYC is the voice for high school students across the City of Austin. Student representation spans throughout AISD, DVISD, RRISD, PFISD, LISD, charter schools, home-schools and private schools. AYC meets monthly following a structured meeting pattern of three types of meetings: *Elected Council Meeting, District Meeting and General Assembly Meeting*. Members discuss issues concerning youth, listen to presentations and engage with City staff as well as organizations throughout the city of Austin. Each meeting begins with a General Assembly meeting, followed by a district and elected council member. Members also participate monthly in community service events.

All interested high schools must have a designated adult sponsor (i.e. teacher, counselor, staff) that will commit to attend some of the monthly meetings and take on the responsibility of checking in with student representatives in between meetings. Each high school must have 2-4 student representatives to participate within AYC. All schools will need to complete a School Form that both the principal and sponsor will sign to acknowledge their committment to AYC.
