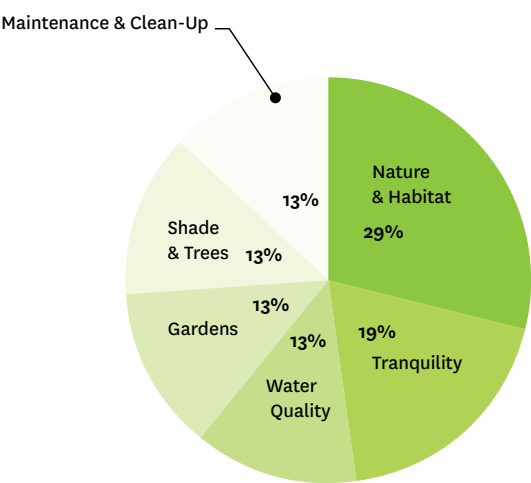

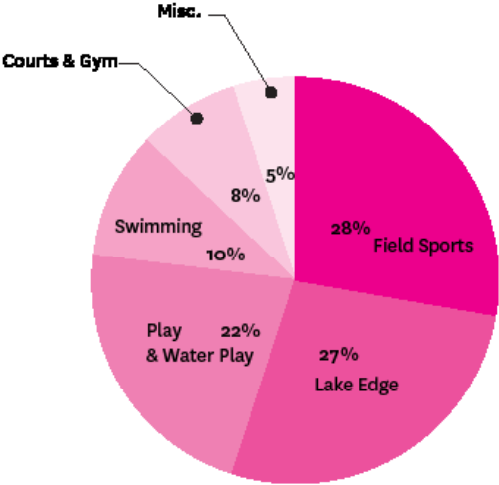

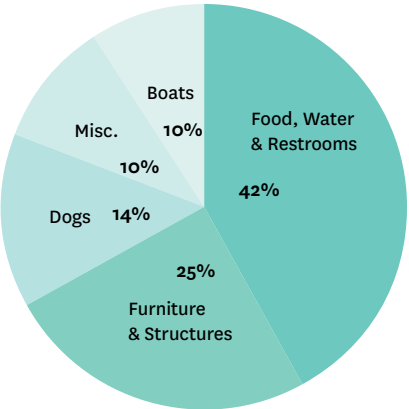

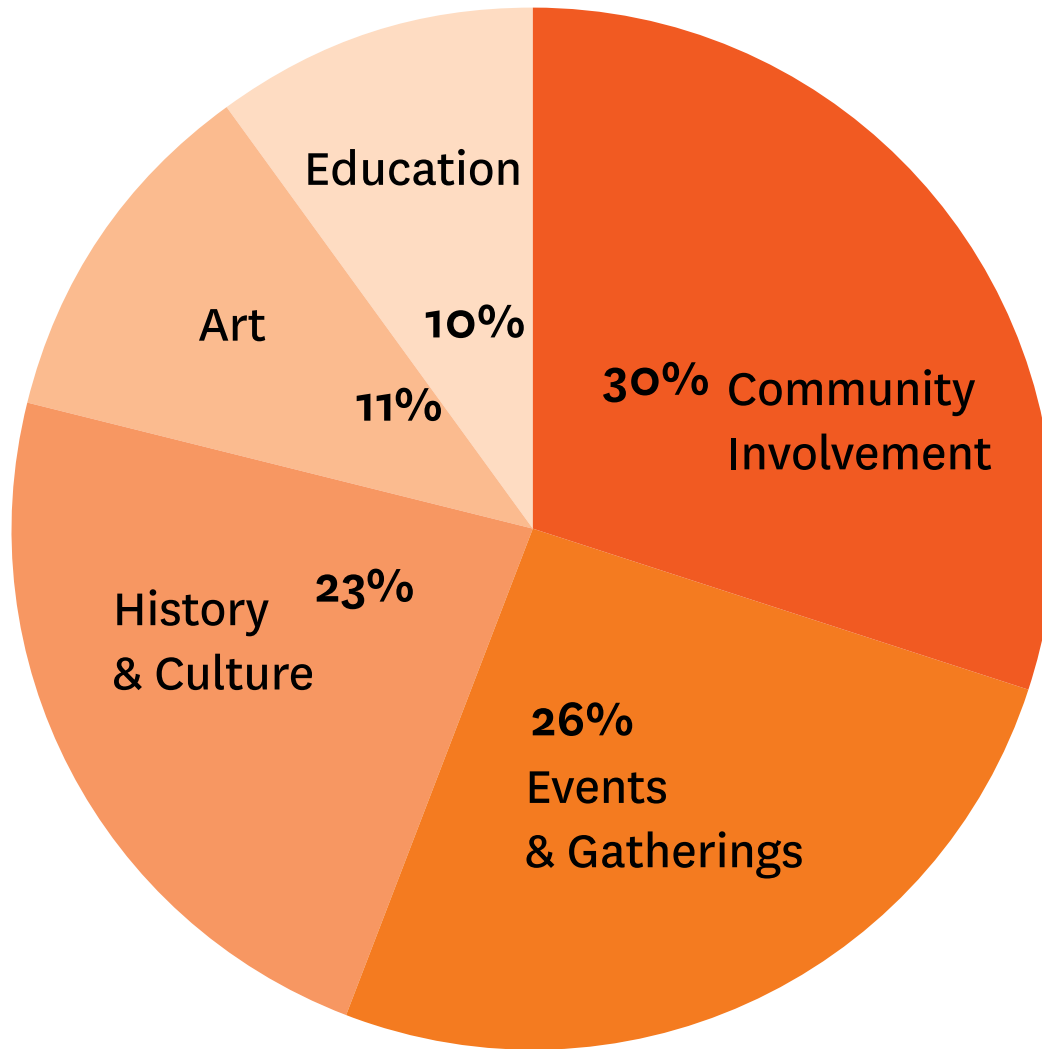

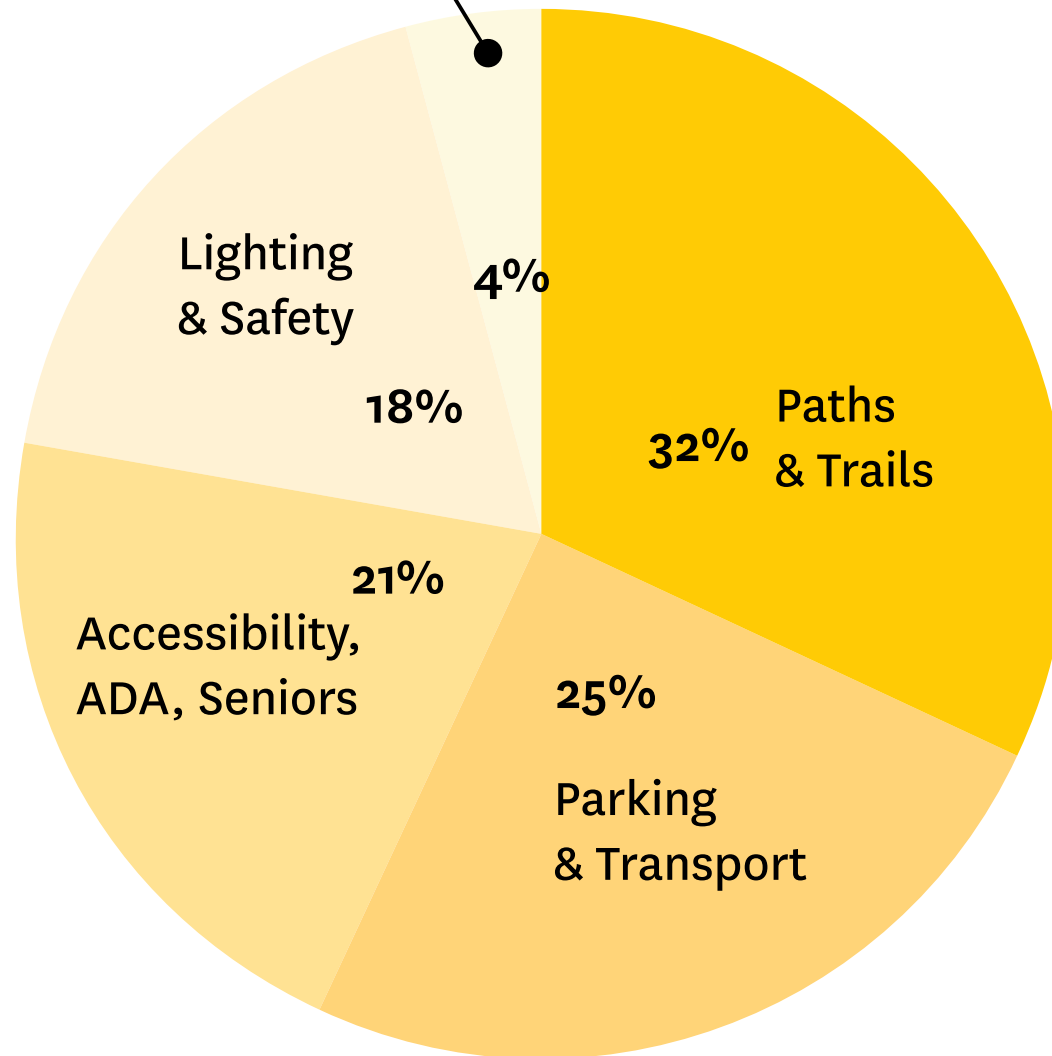

Community Priorities - what we have learned



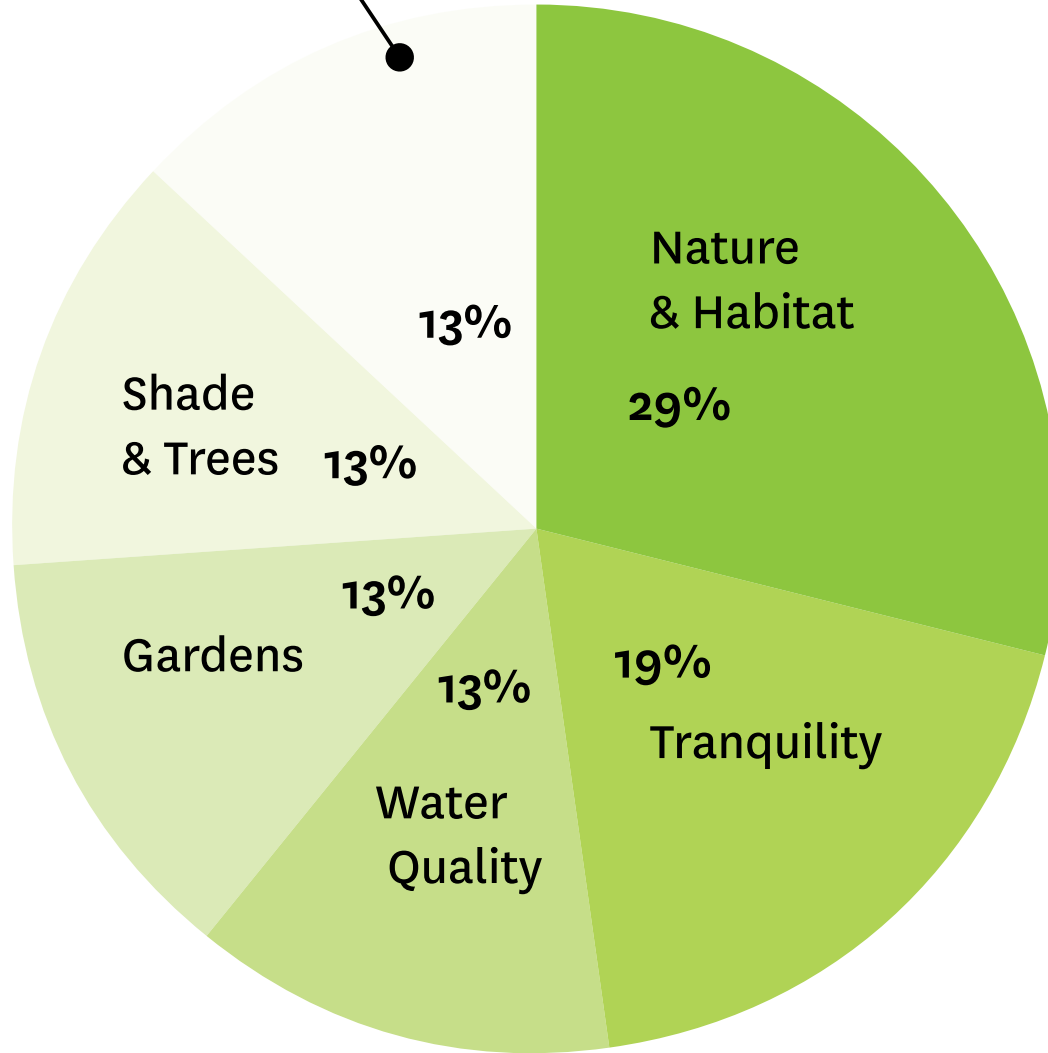

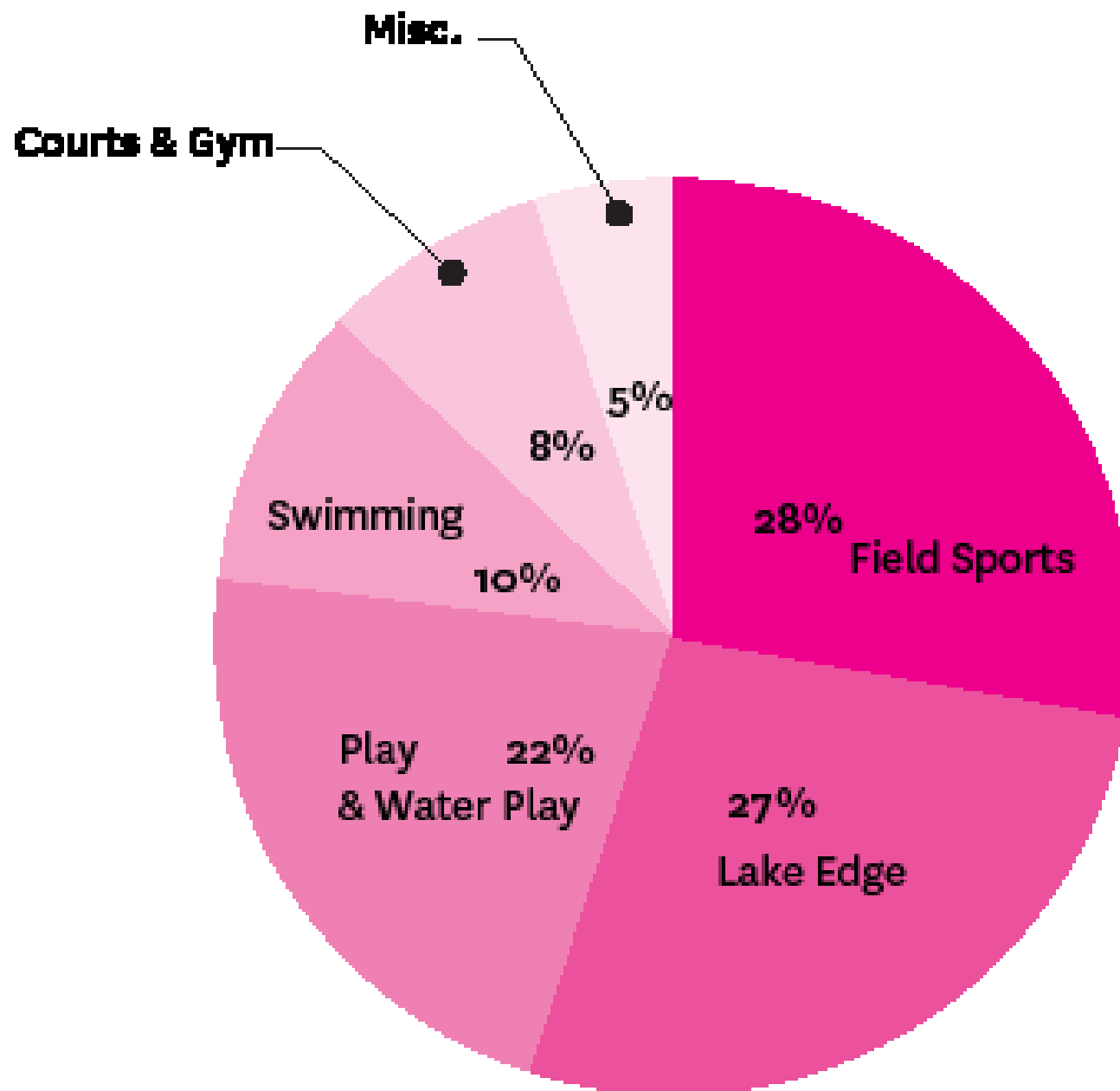

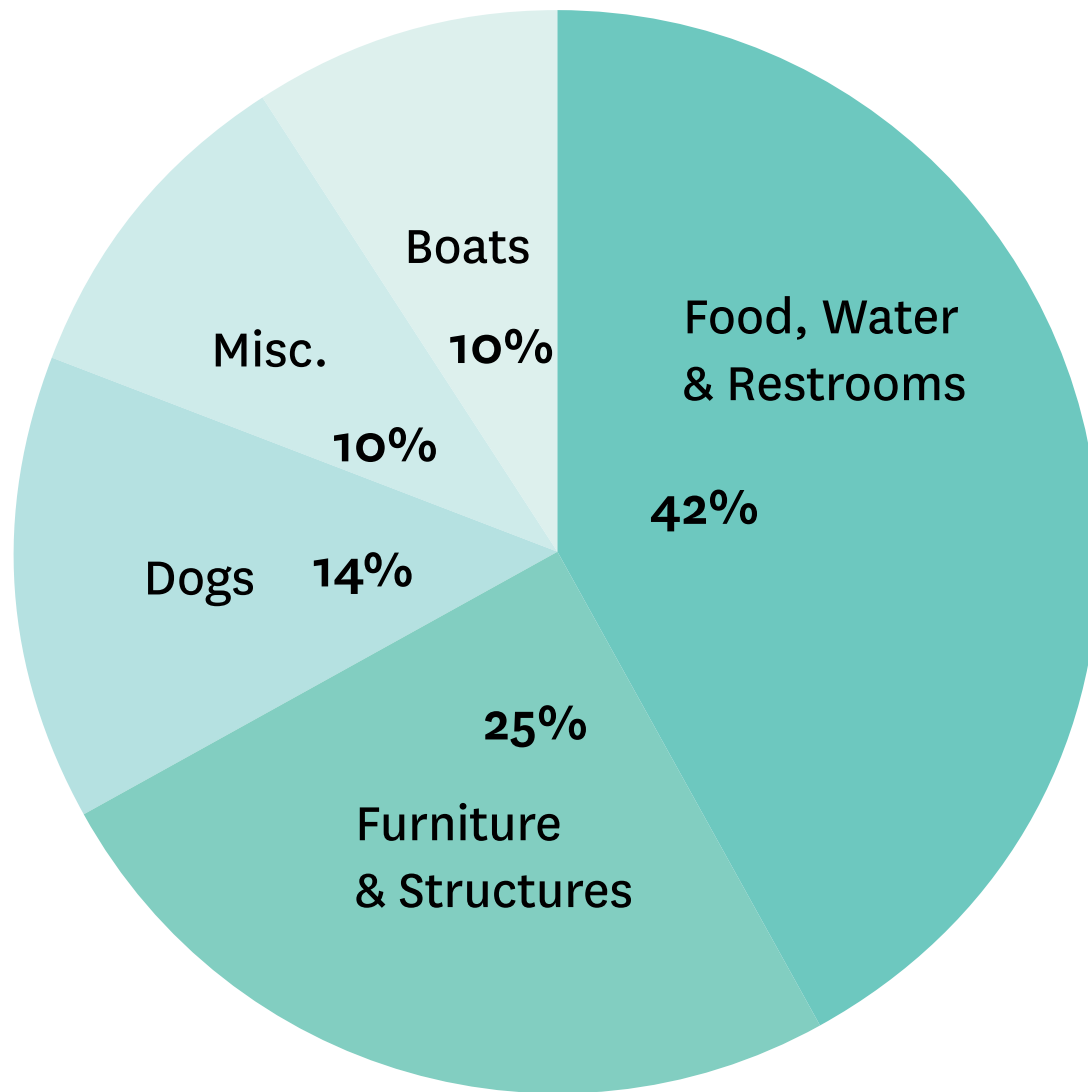
