


Wooldridge Square is an historically significant place. These findings tell us how to preserve and celebrate that history as we improve other aspects of the Square.


#### **AREAS OF CONSENSUS**

- Wooldridge Square has been on the National Register of Historic Places since 1979.
- The existing walk (A) and Bandstand (B) must retain their historical alignment and character.

### **AREAS FOR IMPROVEMENT**

• There is an opportunity to reveal the historical location of Little Shoal Creek (C).







Wooldridge Square does not meet current accessibility standards as required by law. These findings confirm that better access must be considered and reveal ways to make changes sensitive to the existing Square.

#### **AREAS OF CONSENSUS**

• Surveyed constituents do not want accessibility to dominate historic features.

#### AREAS FOR IMPROVEMENT

- Surveyed constituents strongly preferred the proposal of an additional accessible path - shown right - over proposals to realign the existing walk.
- The Square currently lacks ADA compliant access to and onto the Bandstand this was voted by constituents as one of the top five desired infrastructure upgrades.
- Constituents also voiced a desire for ADA compliant parking.

Some constituents suggested an ADA compliant platform off Guadalupe for viewing concerts and events. As a location of primary function in the Square, the Bandstand must be accessible. The preferred path type should follow the existing topography and minimize impact to existing trees. Ġ. Accessible parking proposed on San Antonio Street, where ځ access to the proposed ADA path to the Bandstand is most convenient.



10TH STREET






The Great Streets Program serves to improve the quality of downtown streetscape. These findings tell us which unique aspects of this block to acknowledge as we consider Great Streets.

#### **AREAS OF CONSENSUS**


- Landmark viewsheds in and out of the Square must be preserved. (A, B, & C)
- The Great Streets improvements shall "push" out into the ROW. Parking, curbs and roadways should be modified.

#### AREAS FOR IMPROVEMENT

- Surveyed constituents preferred the hybrid version of Great Streets (plan shown right) over a "one size fits all" implementation.
- 9th and 10th streets should celebrate the proximity and visual connection of the County courthouse and the History center.
- Current limitations include narrow sidewalks and not enough street trees.



Landmark viewsheds include The Austin History Center (A), the Travis County Courthouse (B), and the State Capitol (C).





Constituent feedback tells us how people want to use the Square and how they think it should function. These findings tell us what functions to support when changing areas of the Square.

### **AREAS FOR IMPROVEMENT**

- Wooldridge Square must be able to support constituents' desired uses of the space if it is not used, it will not be successful.
- Several stakeholders commented in support of closing 10th street to vehicular traffic, resulting in a total of ten people speaking in favor of a potential closure.
- Constituents spoke in favor of amenities near the Square, including restrooms, drinking fountains, and flexible space.
