- Concession serves a clear park recreational purpose, and/or serves to enhance a recreational experience in a park.
- Concessions do not require permanent structures or buildings.
- Current Park accounts in good standing.
- Zero waste, or minimized waste with biodegradable containers
- All Concessions permitted in parks may be inspected at any time.

Locations Authorized:

- Temporary Concessions have a list of pre-authorized locations. Other locations may be permitted with site supervisor approval.
- Concessions may be required to meet on site with the Park Maintenance Supervisor or his/her designee to confirm location and access.

Priority Concession Locations – Permitted through a Request For Applications

- Request For Applications Priority Concession Locations March through August
 - o RFA locations 6 month permit
 - Released in January
 - Evaluations in February
 - Selected vendors will sign a Temporary Concession Contract and receive 6 month permit
 - o Application for multiple concessions allowed
 - Concessionaires apply for and operate more than one concession at a time.

Spring Season Permit Term – Permitted through First Come First Serve

- Spring Season March August
 - o 6 month permit
 - Applications accepted in January
 - Applications processed in January/February
 - Permit Term to begin in March
 - Approved vendors will sign a Temporary Concession Contract and receive 6 month permit
 - Lottery if more than 1 application received for the same park on the same day
 - Application for multiple concessions allowed
 - Concessionaires apply for and operate more than one concession at a time.

Fall Season Permit Term - Permitted through First Come First Serve

- Fall Season September February
 - o 6 month permit
 - Applications accepted in July
 - Applications processed in July/August
 - Permit Term to begin in September
 - Approved vendors will sign a Temporary Concession Contract and receive 6 month permit
 - o Lottery if more than 1 application received for the same park on the same day
 - Application for multiple concessions allowed
 - Concessionaires apply for and operate more than one concession at a time.

First Come First Serve Term

- First Come First Serve Available after Spring or Fall Season vendors have been permitted
 - o 6 month or 1 day permit
 - Applications accepted on a rolling basis for available locations
 - Park shall not have the same concession at the space already
 - A prorated fee may be possible to end at the beginning of each season
 - Approved vendors will sign a Temporary Concession Contract and receive up to a 6 month permit
 - Application for multiple concessions allowed
 - Concessionaires may apply for and operate more than one concession at a time in separate parks.
