Summary of Incident

Summary of How the Death Occurred: (max. 30,000 characters)

Summary:

On 4/28/19, two subjects were travelling south bound in a Land Rover on North Capital of Texas Hwy. As the driver and victim travelled in the south bound lanes they stopped at the red light at Courtyard Dr. While stopped at the red light, the victim was fearful of the driver and exited the vehicle. The victim quickly entered another vehicle (Audi) at the stop light and started screaming for help. Once the light turned green, the Audi and the Range Rover began to accelerate south bound through the intersection. The subject driving the Range Rover attempted to side swipe or intentionally collide with the Audi. The driver of the Audi pulled the vehicle over to the shoulder of the road. As the victim exited the Audi and attempted to enter another vehicle, the driver of the Range Rover turned around the vehicle and started driving north bound in the south bound lanes. The Range Rover accelerated and then intentionally collided with several vehicles which resulted in one of the vehicles striking the victim causing bodily injury. The victim continued to be in fear of the driver of the Range Rover and attempted to run away and get into another vehicle. The driver of the Range Rover ran after the victim and grabbed the victim physically trying to pull the victim away. Several citizens who witnessed the event attempted to help the victim and restrain the driver of the Range Rover. The driver of the

Range Rover was eventually able to flee the scene and ran away on foot into a nearby wooded area. One of the witnesses to the incident was able to run after the subject and observed the area of the woods the subject ran into. Austin Police Officers later arrived at the scene and Air and K-9 Units were called in to search for the subject. While conducting their search, Austin Police Officers located and observed the driver of the Range Rover in the woods and began to give him verbal commands. Officers gave verbal commands such as, let me see your hands and drop the weapon. The subject did not obey verbal commands and told the officers he had a gun and would shoot them. An officer observed the subject with what appeared to be an object in his hand and believed it to be a firearm. The officer announced out loud that the subject has a gun several times. The Officers then gave more verbal commands for the subject to drop the gun. The subject continued to not comply with the verbal commands. An officer observed the subject raise a hand and extend the hand out as if pointing a firearm. Another officer saw rapid, sudden movement from the torso of the subject against the commands that were being given. The officers fearing for their life and safety of each other, fired their weapons at the subject. The officers administered first aid to the subject who was transported to the hospital. The subject was pronounced deceased at 6:58 pm.
