RECYCLING HIGHLIGHTS:

» Saving about \$800/year by using reusable water bottles

» Launched an onsite composting program, reducing landfill trash needs

» Swapped Styrofoam packaging for compostable pellets

» Avoided buying nearly 8,740 disposable bottles by switching to a water filtration system

» Connected with businesses to reuse 10 cubic yards of shredded paper after event

Challenges. Nature's Treasures previously self-hauled waste from their operations, including a rock depot, a retail store and a community event center for classes, fairs and rentals. Nature's Treasures staff was aware of the URO, and looking for guidance on how to make it cost-effective for the business.

Solutions. Nature's Treasures contacted Austin Resource Recovery's (ARR) Business Outreach Team for a free Zero Waste Assessment. ARR suggested contracting services to ensure materials were recycled. ARR highlighted loweffort, high-impact actions to reduce service capacity levels, such as:

- Switching to reusable water bottles
- Editing contract language to require recycling at the event center
- Using <u>Austin Materials Marketplace</u> to divert hard-to-recycle materials

Results. Shortly after the Zero Waste Assessment with ARR, Nature's Treasures

- Contracted recycling services
- Installed a water filtration system
- Bought employees reusable water bottles, saving over \$800/year
- Started an onsite composting program
- Exchanged Styrofoam packing peanuts for compostable pellets
- Found 2 businesses via AMM to reuse 10 cubic yards of shredded paper
- Joined ARR's Zero Waste Business Rebate Program

The operational changes helped the business get accepted into the Austin Green Business Leaders program.

Success Factors. For Nature's Treasures, recycling efforts started with one employee. With the help of ARR staff, a business case was made to management for expanding recycling efforts and starting composting. With management committed and staff engaged, the business saw fast results.

Looking Forward. Nature's Treasures plans to assess what remains in their trash to divert more material and identify reduction opportunities. Since containers currently overflow, an increase in recycling capacity is likely. These measures should result in greater cost savings as landfill services are double recycling costs. Nature's Treasures' sustainability efforts prove it truly rocks!
