MEMORANDUM

SUBJECT: Agreed Temporary Suspension of Police Detective Alejandro Torres #4206
Internal Affairs Control Number 2016-1347

Pursuant to the provisions of Chapter 143 of the Texas Local Government Code, Section 143.052, and Rule 10, Rules of Procedure for the Firefighters', Police Officers' and Emergency Medical Service Personnel's Civil Service Commission, I have temporarily suspended Detective Alejandro Torres #4206 from duty as a police officer for a period of ninety (90) days. The temporary suspension is effective beginning on July 21, 2017, and continuing through October 18, 2017.

I took this action because Detective Torres violated Civil Service Commission Rule 10.03, which sets forth the grounds for disciplinary suspensions of employees in the classified service, and states:

No employee of the classified service of the City of Austin shall engage in, or be involved in, any of the following acts or conduct, and the same shall constitute cause for suspension of an employee from the classified service of the City:

- L. Violation of any of the rules and regulations of the Fire Department or Police Department or of special orders, as applicable.

The following are the specific acts committed by Officer Torres in violation of Rule 10:

On February 1, 2017, Detective Alejandro Torres was interviewed by Internal Affairs regarding complaints signed by a Sergeant and his Commander. Although Detective Torres was exonerated for the initial complaint, he acknowledged in his second interview, held on April 12, 2017, that he provided misleading statements during the course of the investigation. Officer Torres conceded he should have been forthcoming from the onset.

By these actions, Officer Torres violated Rule 10.03(L) of the Civil Service Rules by violating the following rules and regulations of the Austin Police Department:

➤ **Austin Police Department Policy 900.4.3: General Conduct and Responsibilities: Neglect of Duty**

900.4.3 Neglect of Duty

Employees will satisfactorily perform their duties. Examples of unsatisfactory performance include, but are not limited to:

- (i) Employees are expected to be truthful at all times in the performance of their duties. However, there may be instances where, initially, the employee has not been truthful; but, before the investigation is complete, the employee provides an accurate and detailed accounting of their true culpability in a situation, and accepts full responsibility for their actions. In those cases, the Chief may consider each case on a fact-specific basis.

In addition to this agreed suspension, Detective Torres agrees to the following additional terms and conditions:

- 1) Detective Torres agrees to a one (1) year probationary period, with additional requirement that, if during the probationary period, he commits the same or similar act of misconduct for which he being suspended, as determined by me, he will be indefinitely suspended without the right to appeal that suspension to the Civil Service Commission, to an Independent Third Party Hearing Examiner, or to District Court. The one year period begins on the day Detective Torres returns to duty after completing his agreed suspension. Should Detective Torres commit the same or similar violation outside the one year period, he will be indefinitely suspended but retains the right to appeal.
- 2) Detective Torres agrees that he, and all others claiming under him named herein or not, fully discharge, release and waive any and all known or unknown claims or demands of any kind of nature whatsoever that he now has, or may have in the future, including without limitation, claims arising under any federal, state or other governmental statute, regulation, or ordinance relating to employment discrimination, termination of employment, payment of wages or provision of benefits, Title VII of the Civil Rights Act of 1964, as amended, the Civil Rights

Act of 1991, the Americans with Disabilities Act of 1990, as amended, the Family and Medical Leave Act, the Fair Labor Standards Act, and the Texas Commission on Human Rights Act, against the City of Austin, the Austin Police Department, or their respective agents, servants and employees, arising from the above-referenced incident, and any actions taken as a result of that incident, including but not limited to, the negotiation and execution of this agreed temporary suspension.

- 3) Detective Torres understands that this temporary suspension may be taken into consideration in the Chief's determination whether a valid reason exists to bypass him for a future promotion in accordance with APD Policy 919.
- 4) Detective Torres acknowledges that he had the opportunity to discuss this agreed suspension and the additional terms and conditions set forth herein with an attorney of his choice prior to signing his acceptance where indicated below.

By signing this Agreed Discipline, Detective Torres understands and agrees that I am forgoing my right to indefinitely suspend him for the conduct described above and that by agreeing to the suspension, Detective Torres waives all right to appeal to this agreed suspension to the Civil Service Commission, to an Independent Third Party Hearing Examiner, to District Court, and he may not file a grievance under Article 20 of the Meet and Confer Agreement.
