



## HOW TO OBTAIN A CHAUFFEUR'S PERMIT:

- Nationwide Criminal Record Background Check.** Fingerprints are taken by **IdentoGO**. To schedule an appointment go to [uenroll.identogo.com](http://uenroll.identogo.com) or call **888-467-2080**.

**IMPORTANT:** In order for us to receive your records, you need to give our Service Code: **11GYVN** to IdentoGO. After you get fingerprinted, there is a wait of 48 to 72 hours before we get the results. **Please call us to confirm that we have received your fingerprints** before visiting our office. Phone numbers are listed at the end of this guideline. **(DO NOT GET FINGERPRINTED AGAIN IF YOU HAVE ALREADY USED THIS SERVICE CODE. CALL OUR OFFICE TO CONFIRM IF WE HAVE YOUR BACKGROUND.)**

- Valid Driver's License**

**If not a citizen of the United States**, you will need to bring also your **Employment Eligibility Card** (Employment Card, Resident Card, I-90, etc.) & **Social Security Card**.

**If citizenship has been granted**, please bring your **Naturalization Certificate** or **USA Passport** & **Social Security Card**.

- Chauffeur's Permit Application** (attached) – There is a \$20.00, non-refundable application fee. **Page 3 needs to be notarized in Travis County. Please fill out all pages. However, wait to sign your Application until you are in front of the notary.** If you would like for our office to notarize your application, there will be a \$6.00 service fee added to the cost of the Chauffeur Permit.

- 3A Certified Texas Driving Record** can be obtained @ [www.dps.texas.gov](http://www.dps.texas.gov). Please make sure to select **Type 3A – Certified** when prompted.

**If your driver's license is less than 3 years old**, you will need to bring also a Certified Driving Record from your previous state of residence **or** proof of at least 3 years Texas residency by bringing a copy of your electric bill, bank statement, income tax return, insurance card, or letter from housing that reflects this. **Driving records cannot be older than 30 days.**

**If you have any moving violations within the past 3 years**, you will need proof of taking a Defensive Driving Class dated **after the conviction date** of the offense regardless of your driver's license type.

- Take a Test in our Location.** The test will consist of questions pertaining to customer service, traffic violations, landmarks, and Ordinance related questions. To familiarize yourself with our Ordinance follow the link to: [Chapter 13-2 Ground Transportation Passenger Services](#). Testing is administered Monday through Friday, 8:30am to 11:30 am and we are located at **1501 Toomey Rd. Austin, TX 78704**.

### FREQUENT QUESTIONS:

**What if I do not have a Texas Driver's license?** You will be issued one of two different types of Conditional Chauffeur Permits:

- For college students**, you will be required to show a current year transcript. The permit will need to be renewed annually. You will NOT have to obtain a Texas driver's license as long as you are enrolled as a student.
- For people who relocated to Texas**, you will have a 90 day conditional permit. After 90 days, you must show proof of a Texas Driver's license and a 3A Certified Texas Driving Record in order for us to issue you a non-conditional permit.

**How many times can I take the test?** One per day for up to 3 attempts. Should you not pass by the third time, you must wait 30 days and return with all new documents

If you have been a **resident of Texas for less than 3 years**, you must provide a complete driving record from each state of residence for 3 years preceding the date of application. Each driving record must be issued and certified by the appropriate governmental entity not earlier than the 30<sup>th</sup> day before the date the application is submitted to the department.
