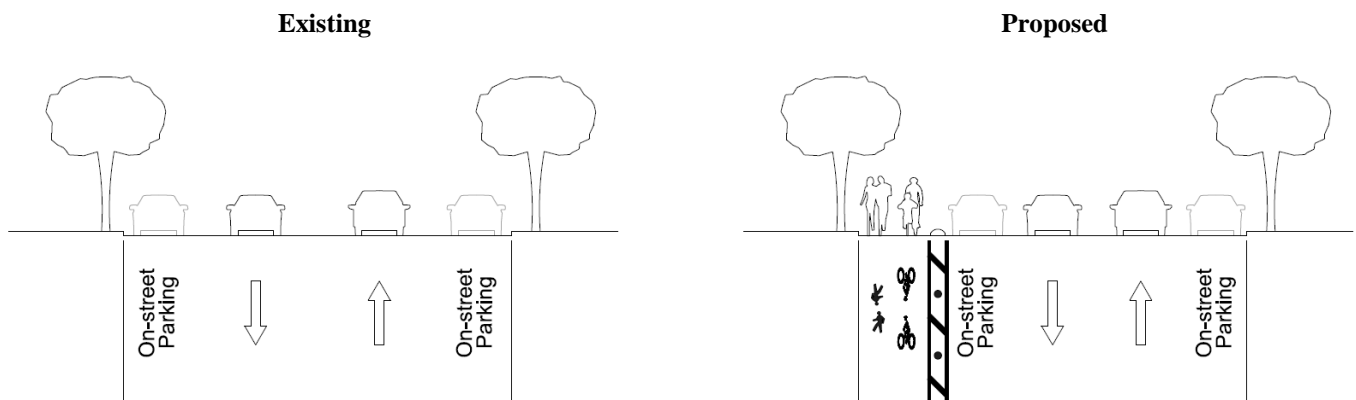
This is a second notification and contains updated information related to this project. Local stakeholder feedback was used to re-evaluate the proposed project, resulting in expanding the shared-use pathway to include portions of Willow Bend Drive and Chimney Rock Drive to Lamar Boulevard. The updated map below shows the full extent of the proposed project.

In response to requests by area residents, the Austin Transportation Department (ATD) is assessing a new street configuration to provide a shared use pathway along Old Cedar Lane and Willow Wild Drive to better accommodate people using the street by walking and riding a bicycle. You are receiving this notification because you live on and/or own property adjacent to Old Cedar Lane and/or Willow Wild Drive in Austin, Texas or are otherwise registered as a stakeholder in the area.

In response to citizen feedback, the Austin Transportation Department will be implementing an on-street two-way shared use path along Old Cedar Ln and Willow Wild Dr as shown in Figure 1.

Figure 1 – Typical Cross Sections for Willow Wild Dr. and Old Cedar Ln.



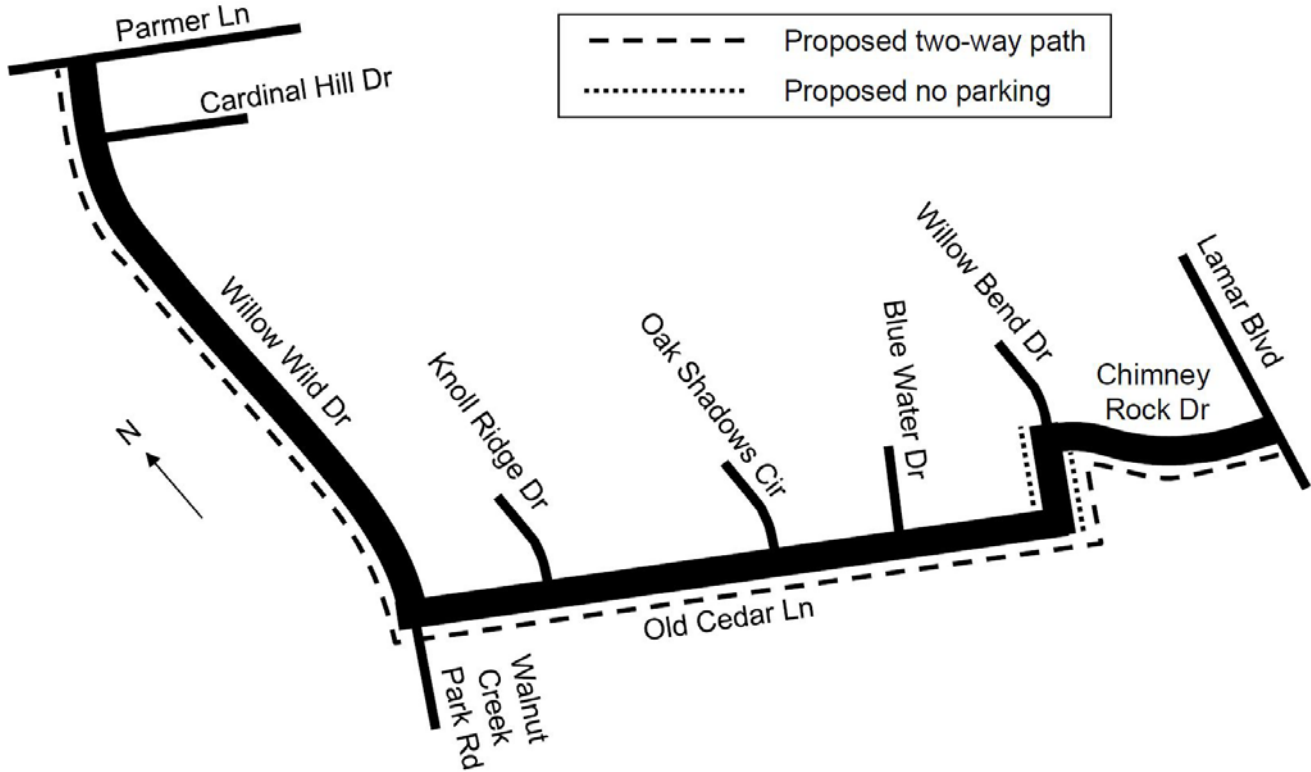
Initial plans were for the shared use path to be installed onto Willow Wild Dr from Parmer Ln to Old Cedar Ln, and on Old Cedar Ln from Willow Wild Dr to its end at Willow Bend Dr.

During the first public meeting several area residents identified a walking route currently being utilized by children walking to school along Old Cedar Ln onto Willow Bend Dr and Chimney Rock Rd to connect to Lamar Blvd. To accommodate this walking traffic the Austin Transportation Department is planning to install the on-street shared use path along this route as well as Willow Wild Dr and Old Cedar Ln.

Old Cedar Ln and Chimney Rock Rd are wide enough to accommodate a shared use path and on-street parking on both sides as shown in the cross section drawing in Figure 1. Willow Bend Dr is not wide enough for parking

to be preserved. Parking restrictions are planned for Willow Bend Dr between Old Cedar Ln and Chimney Rock Dr as shown in Figure 2.

The Austin Transportation Department will be holding a second open house meeting to discuss the proposed two-way shared use path with area stakeholders and residents on July 20th, 2017 from 6 to 7pm at Northside Church located at 12424 Schofield Farms Dr.
