Event will not distribute or allow single-use carryout bags, Styrofoam or glass in City of Austin parks, facilities or on public rights of way. ☐ Proper permitting from the City of Austin. ☐ Part 1 Zero Waste Event Rebate Application Form must be submitted at least 10 business days prior to event date. ☐ Event will provide recycling of plastic bottles, aluminum cans, and cardboard. Other items will be accepted if discussed pre-event with ARR staff. ☐ Paid staff to monitor diversion efforts if event is in the evening or the event will sell or serve alcohol. Applicant is not eligible for more than two Zero Waste Event Rebates per calendar year.
