





Proposed Carryout Bag Regulations

Austin City Council Resolutions

- > April 19, 2007
 - Directed staff to evaluate and recommend strategies for limiting the use of plastic bags
- > April 10, 2008
 - Based on stakeholder group advice, adopted plan for 50% reduction and established voluntary program.
- > June 24, 2010
 - Directed staff to determine the cost to Austin taxpayers of processing plastics bags

Austin City Council Resolution

- ➤ August 4, 2011
 - •Directed staff to develop a city ordinance providing a "comprehensive phase-out of single-use plastic bags offered at retail checkouts"
 - •Requested by Council to expand the public discussion to include paper bags and market drivers such as fees

Bags Prohibited

- **≻**Retail Single-Use Carryout bags
 - Plastic & Paper Single-Use Bags
 - Retailers within city limits

Bags Permitted

- > Reusable Carryout bags
 - Consumer Choice: Cloth, Plastic, and Paper checkout options
 - Required recycled content, minimum thickness, with handles.
 - Plastic: minimum 4.0 mil and 50% recycled content
 - Paper: minimum 65 lb weight and 100% recycled content
 - Certified by Sustainable Forestry Initiative (SFI) or Forest Stewardship Council (FSC)

Implementation Timeline

- > Phase 1: One Year Education Period
 - Jan 1, 2012 Dec 31, 2012
 - Public Education Campaign
- Phase 2: Three Year Transition Period
 - Jan 1, 2013 Dec 31, 2015
 - Single Use Carryout Bags only upon request
 - \$0.25 surcharge per single-use bag
- **▶** Phase 3: Full Implementation
 - Jan 1, 2016
 - No distribution or sale of Retail Single-Use Carryout bags

> Temporary Surcharge

- During three year transition period only
- Not charged to customers using Lone Star Card
- Retailer keeps 10% for administration
- City use the funds to promote use of reusable carryout bags

Administrative Variance

- Director may grant variance based on undue hardship
- Variance must be minimum departure from regulations

Exemptions

- Dry Cleaner Bags and Yard Waste Bags
- Produce, Meat, and Frozen Foods Bags
- Door-hanger Bags and Newspaper Bags
- Prescription Drug Carry-out Bags
- Beer, Wine and Spirits Carry-out Bags
- Restaurant Carry-out Bags

Other Elements

- Retailer Signage Requirements
- Bags printed message: "Reusable and Recyclable"
- Prohibits single-use carryout bags at City facilities, at events on City property, and at citysponsored events
