



IRRIGATION UPGRADE RESIDENTIAL REBATE

Austin Water's **Irrigation Upgrade Rebate** helps single-family residential customers with costs for materials to improve their irrigation system's water efficiency.

WATER SAVINGS

- Reduces **water waste** by making your irrigation system more efficient.

REBATE AMOUNT

- **Up to \$400 total rebate per property** (*materials only, labor & tax not included*)
 - o Rain Sensor or Soil Moisture Sensor - **up to \$50**
 - o Irrigation System Pressure Regulating Valve (PRV) - **up to \$100**
 - o Pressure Regulating Components other than PRV (*such as heads, station valves, and valve attachments*) - **up to \$100**
 - o Converting station from spray to multi-stream, multi-trajectory rotor nozzles - **\$4 a nozzle up to \$100**
 - o Converting a station to drip - **up to \$50 per station**
 - o Capping a station - **\$50 per station**

ELIGIBILITY

- **Applicant:**
 - o Must be a single-family customer of Austin Water or a **qualifying water provider**
 - o Property may not have already participated in this program (*call 512-974-2199 to check*)
 - o Agrees to any needed post-installation inspections by Austin Water
- **Irrigation System:**
 - o Upgrades must be to improve an existing system. New systems and/or expansions of existing systems do not qualify
 - o The homeowner or a licensed irrigator must do the irrigation work (**Texas Administrative Code Chapter 344**)
 - o You must convert an entire station if you are:
 - Installing pressure compensating heads
 - Converting from spray to multi-stream, multi-trajectory rotor nozzles
 - o If you convert a station to drip, you must include the pressure regulation and filter method noted on the invoice
 - o If you cap a station, you must remove the station valve and keep it for final inspection
 - Cap must remain visible until final inspection is complete
 - o Must have an appropriate backflow prevention device

CHECKLIST

- Meet all eligibility requirements
- Submit the application **within 30 days** of completing the irrigation upgrades and include:
 - Itemized paid-in-full receipts **with charges for parts separated from labor costs** and line item detail for each category requested
