During this quarter, Austin welcomed thousands of visitors for South by Southwest, including President Barack Obama and First Lady Michelle Obama. President Obama is the first sitting president to ever attend SXSW, one of Austin's signature events.

Besides working to make sure the festival was safe for residents, workers, concert-goers and visitors, the Austin Code Department has been kept busy by a number of other programs and projects.

For example, due to the changes made to the Short-Term Rental ordinance by City Council, our department has been making sure the public understands these changes and their responsibility in working with us to abide by them. In an effort to educate the public on these new changes, we have begun a social media campaign and held a very successful video Q&A to answer questions. In the third quarter, we will expand this educational campaign to reach more STR owners, managers and visitors.

Our Repeat Offender Program continues to grow; there are now 77 registered properties in the program.

We are conducting an internal evaluation related to the City Neighborhood Enhancement Team to determine 'next steps.'

While these are only a few highlights for this quarter, we are continuing to improve and help our department be better at achieving our mission. 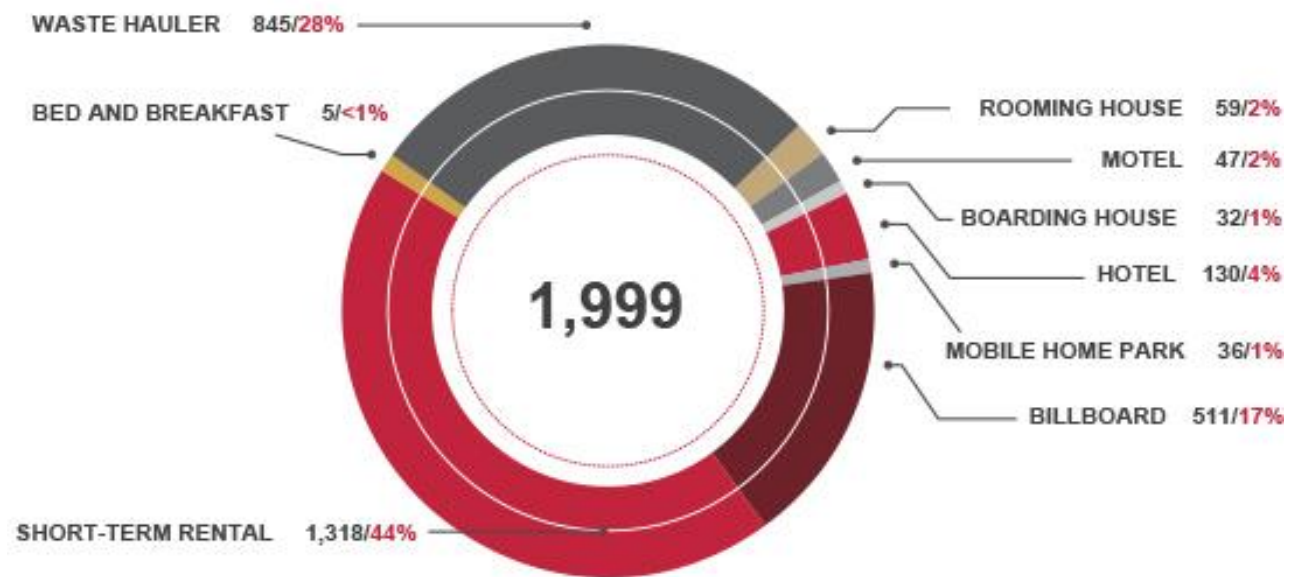

### **SHORT TERM RENTAL UPDATE**

On Feb. 23, the Austin City Council approved significant changes to the Short-Term Rental ordinance. The revised ordinance imposed new requirements for advertising, set occupancy limits, placed new requirements on those requesting STR licenses, and created a process for denying or suspending a license, along with an appeal process. The ordinance also set limits on the distance between Type 2 STRs, established requirements related to inspections, noise and music and prohibited certain types of

gatherings. Eventually, the ordinance will prohibit Type 2 short-term rentals in residential areas.

The Austin Code Department PIO team has launched an extensive STR public education and awareness campaign that includes printed materials, updates to the website, a video, ads, and other materials as well as social media postings to inform short-term rental property owners, managers, tourists and the general public about the new ordinance.

## **NEIGHBORHOOD ENHANCEMENT TEAM UPDATE**

Currently, there is an internal evaluation process taking place that will allow us to determine 'next steps' for the City of Austin Neighborhood Enhancement Team pilot.

The NET pilot was implemented in February 2015 by City Council Resolution to evaluate ways to address code compliance health and safety issues and crime in neighborhoods that are part of the Restore Rundberg initiative. The pilot specifically was created to study the effects of using an integrated public, private and community approach to reducing blight and other quality of life issues within the targeted area of the North Lamar/Georgian Acres neighborhoods.

We will provide information at a later date on what happens next with NET.

## **VOLUNTEER PROGRAM**

The Austin Code Community Volunteers kicked off its recruitment efforts by hosting a series of orientation/meet and greet sessions starting in August 2015. We held 8 such sessions throughout the course of the fall and winter with 32 prospective volunteers attending and a total of 48 interested parties who made contact during the course of the recruiting efforts. In addition to providing an opportunity to complete a program application and other necessary paperwork, prospective volunteers were able to learn more about the program and contribute invaluable feedback as to how the Austin Code Community Volunteers could improve their neighborhoods.





With the volunteer training and other program details finalized, we began holding training sessions in March 2016. To date, we've held 4 training sessions, with 13 volunteers attending. Our next session is scheduled for Thursday, May 12 from 6:00 - 8:00 pm at our Rutherford Lane campus. As we continue our recruiting and training efforts, we can't wait to see the many positive impacts the Austin Code Community Volunteers will achieve as the program gets up to full speed!
