- 5. The applicant must provide the following information and attach as part of the application:
  - a. Copy of a valid City of Austin Operating Authority issued by the Department of Public Works and Transportation. This does not apply to Hotel, Taxicab Operators or Off-Airport Parking companies.
  - b. A certificate of insurance as proof of insurance coverage, listing the City of Austin as additional insured.
  - c. A list containing the names and valid driver's license numbers of each driver authorized to operate a ground transportation vehicle for this company on airport property.
- 6. A \$75.00 per vehicle non-refundable permit fee must be submitted with this application if permitting for a sixmonth period. Permits expire twice a year, June 30 and December 31. We do not prorate at any time.
- 7. I understand that any omitted information found to be inaccurate could result in the denial of this application for an Airport Ground Transportation Service Operating Permit. I agree to abide by the Austin-Bergstrom International Airport's Ground Transportation Rules and Regulations, Chapters 13-1 and 13-2 of the Austin City Code. I understand that this permit is revocable at any time by the Department of Aviation Executive Director or Designee.
- 8. <u>Agreement subject to Title 49 CFR Part 23</u>. This Agreement is subject to the requirements of the U.S. Department of Transportation's Airport Concession Disadvantaged Business Enterprise Program Regulations set forth in Title 49 CFR Part 23 ("Part 23"). Permittee agrees (a) that it will not discriminate against any business owner because of the owner's race, color, national origin, or sex in connection with the award or performance of any concession agreement, management contract, or subcontract, purchase or lease agreement or other agreement covered by Part 23; and (b) to include the above statements in any subsequent concession agreement or contract covered by Part 23 that it enters and cause those business to similarly include the statements in further agreements.
- 9. <u>ACDBE Requirements</u>. In accordance with <u>49 CFR</u> Part 23, the City has implemented an Airport Concession Disadvantaged Business Enterprise ("ACDBE") plan ("City ACDBE Plan") to ensure that ACDBE's as defined in Part 23 have an equal opportunity to receive and participate in concession opportunities. If applicable and as determined by staff, Permittee may be required to submit to the City an ACDBE Compliance Plan ("Compliance Plan"), which is incorporated by reference, identifying the ACDBE firms that will participate in this Permit. Permittee shall comply with the provisions of Part 23, the City ACDBE Plan and the Compliance Plan. Permittee shall not employ any subcontractor or sub-permittee except as provided in the Compliance Plan, and shall not substituted or remove any subcontractor or sub-permittee identified in the Compliance Plan unless the substitute has been approved by the City in accordance with the City ACDBE Plan. Permittee shall timely submit to the City all reports required under Part 23 or the City ACDBE Plan to demonstrate Permittee's compliance with its Compliance Plan.
- 10. Nondiscrimination and Affirmative Action. Permittee, for itself, its successors and assigns, as a part of the consideration of this Agreement, does hereby covenant and agree that: (1) no person on the grounds of race, color, religion, sex, national origin or ancestry, or age, shall be excluded from participation in, denied the benefits of, or otherwise be subjected to discrimination in the use of said Premises and improvements; (2) that in the construction of any improvements on, over, or under such land and the furnishing of services thereon, no person on the grounds of race, color, religion, sex, national origin or ancestry, or age, shall be excluded from participation in, denied the benefits of, or otherwise be subjected to unlawful discrimination; (3) that Permittee shall use the Airport facilities in compliance with all other requirements imposed by, or pursuant to, 49 CFR Part 21 (Nondiscrimination in Federally Assisted Programs of the Department of Transportation), as said regulations may be amended; and (4) Permittee assures that it will undertake an affirmative action program as required by 14 CFR Part 152, Subpart E, Non-discrimination in Airport Aid Program, to ensure that no person shall on the grounds of race, color, religion, national origin or ancestry, sex, age, or physical or mental handicap be excluded from participating in any employment activities covered in 14 CFR Part 152, Subpart E, or such employment activities covered in Chapters 5-3 and 5-4 of the Austin City Code. Permittee assures that no person shall be excluded on these grounds from participating in or receiving the services or benefits of any program or activity covered by this Section. Permittee assures that it will require that any covered subtenant similarly will undertake affirmative

Provided, however, that, in the event Permittee becomes involved in, or is threatened with, litigation with a subcontractor or supplier as a result of such direction, the Permittee may request the City to enter into such litigation to protect the City's interests, and in addition, Permittee may request the United States to enter into such litigation to protect the
