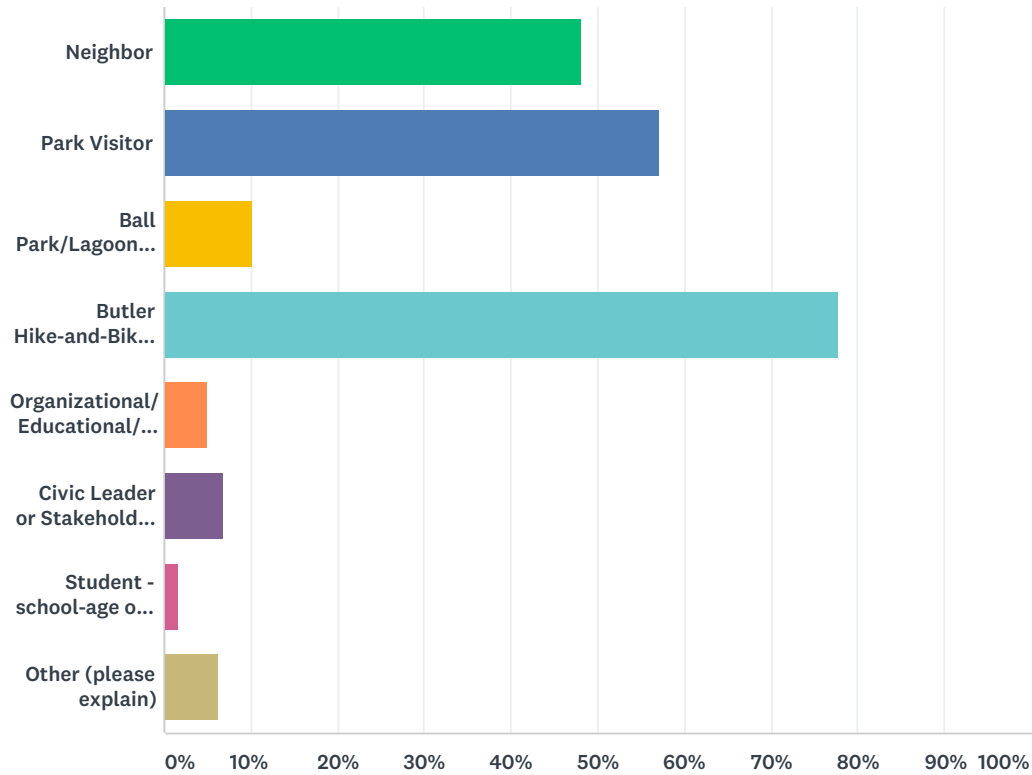


Q1 What best describes your activity related to Holly Point? Please check all that apply.

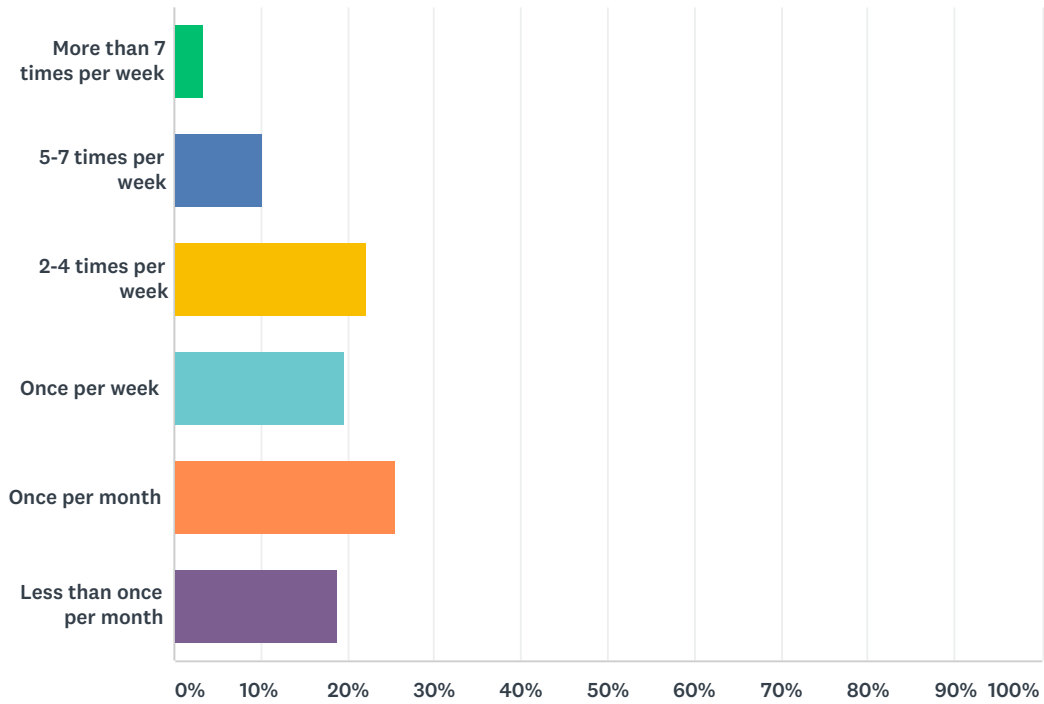

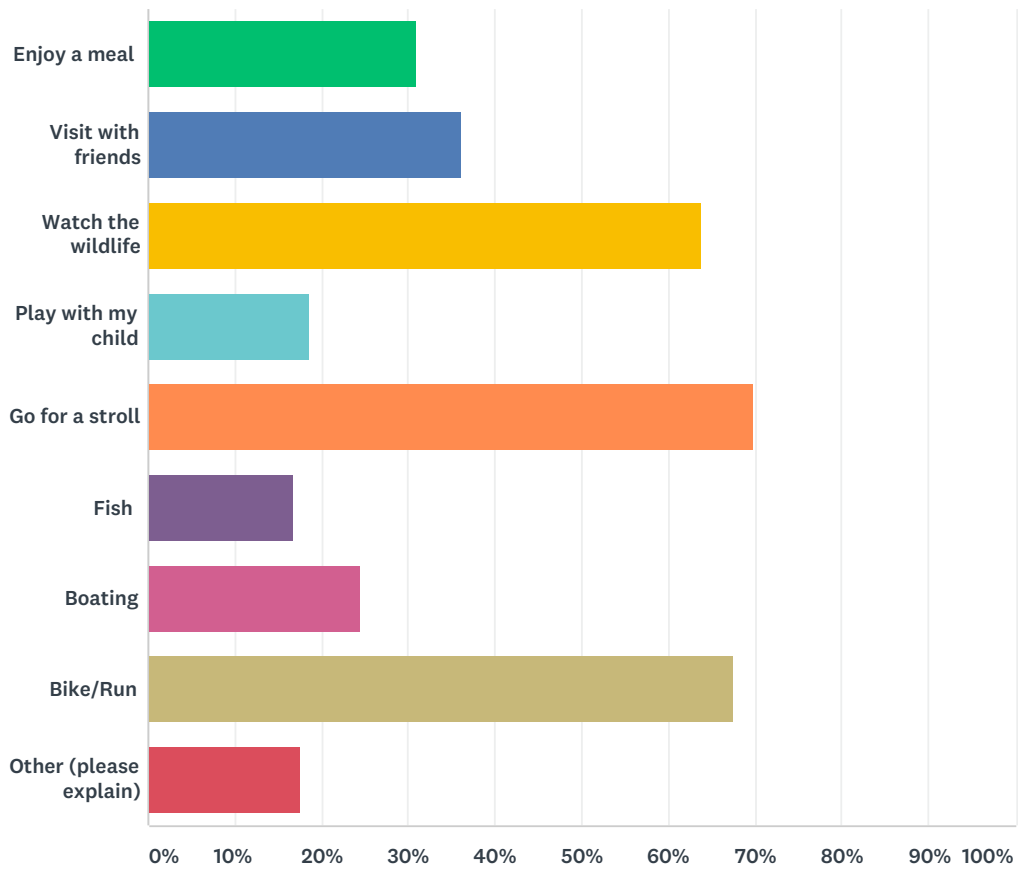
