Mental Health Disaster Preparedness

- Coordinate the mental health community crisis response to disasters with HHSD.
- Provide on-going training to the Disaster Mental Health Team and the expanded volunteer network of mental health professionals in the community
- Continue to maintain ATCMHMR's Computer Aided Credentialing and Tracking Update System (CACTUS)
- Provide disaster mental health education/ training and consultation to schools in the event of a disaster
- Maintain the Business Continuity Plan and provide key information to the city as part of the City's Emergency Preparedness and Response Plan.

Prevention, Education & Awareness Opportunities:

ATCMHMR will support the New Milestones Foundation in its mission of "eradicating stigma" through community forums, a film festival and other prevention, education and awareness activities.

ATCMHMR will provide the primary support to the Mayor's Mental Health Task Force Monitoring Committee (MMHTFMC) in their effort to achieve established goals.

- System Mapping to provide a clear picture of strengths, weaknesses, and gaps in existing mental health services and help influence policy decisions about effective and cost-efficient resource development and allocation over the coming year.
- Development of a comprehensive housing plan delineating the needs of people with mental illness and the possible financing strategies to meet these needs.
